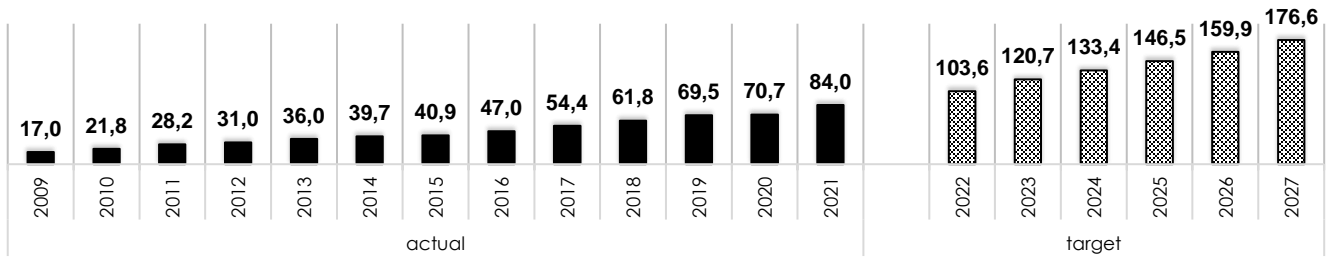

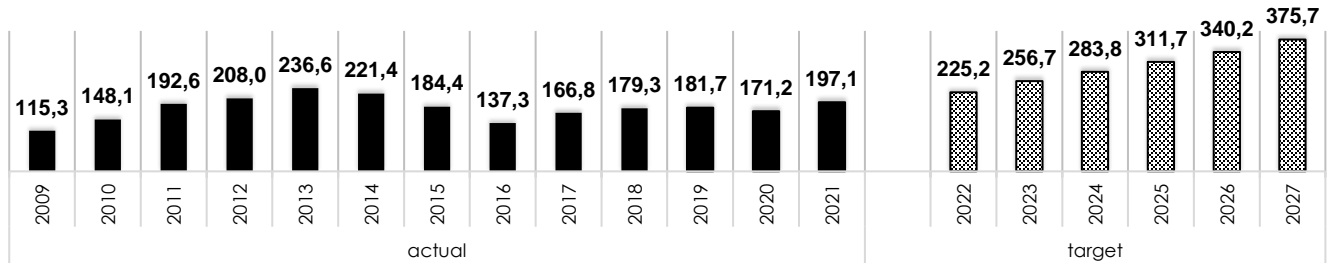

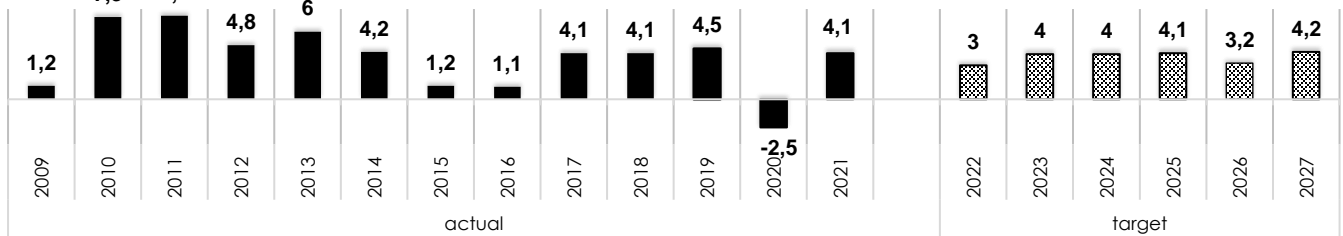
GD, growth in annual terms, trln KZT



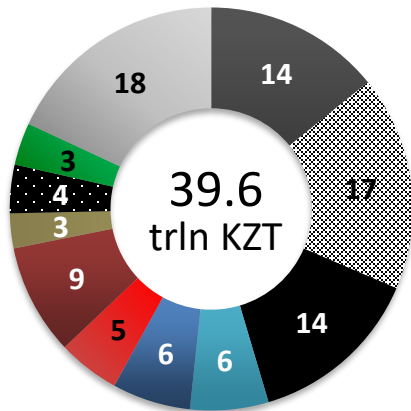
GDP growth in annual terms, bn USD

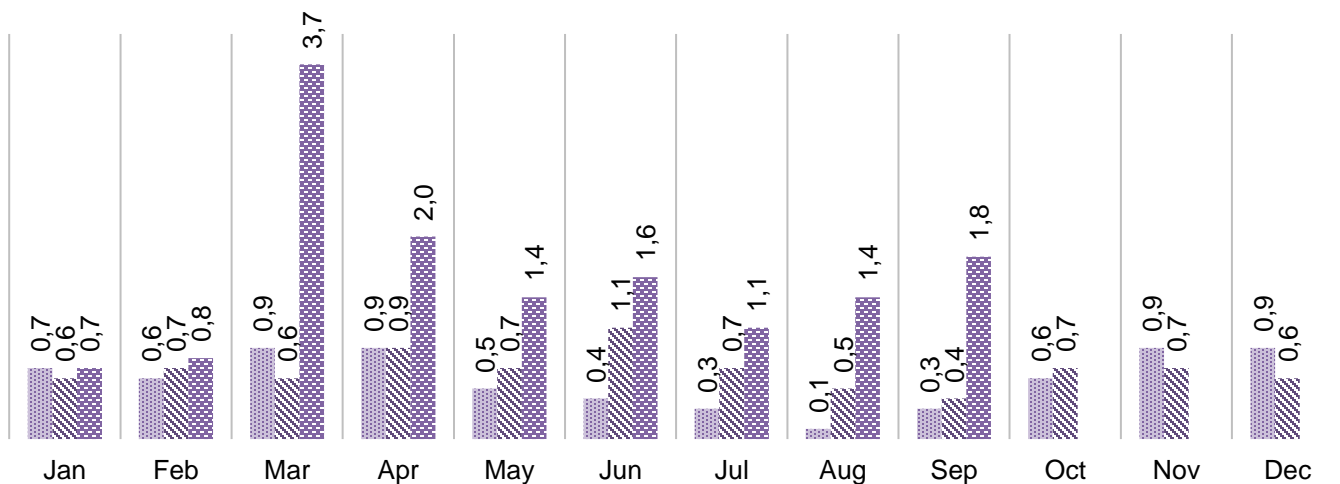

The consumer price index in October 2022 compared to the previous month was 101.6 %:

- food prices rose by 1.4 %;
- non-food products rose by 1.7 %,
- paid services increased by 1.7 %,

Since the beginning of the year (October 2022 compared to December 2021), prices and tariffs for consumer goods and services increased by 17.2%, including food products – by 21.2 %, non-food by 16 %, paid services by 12.6 %

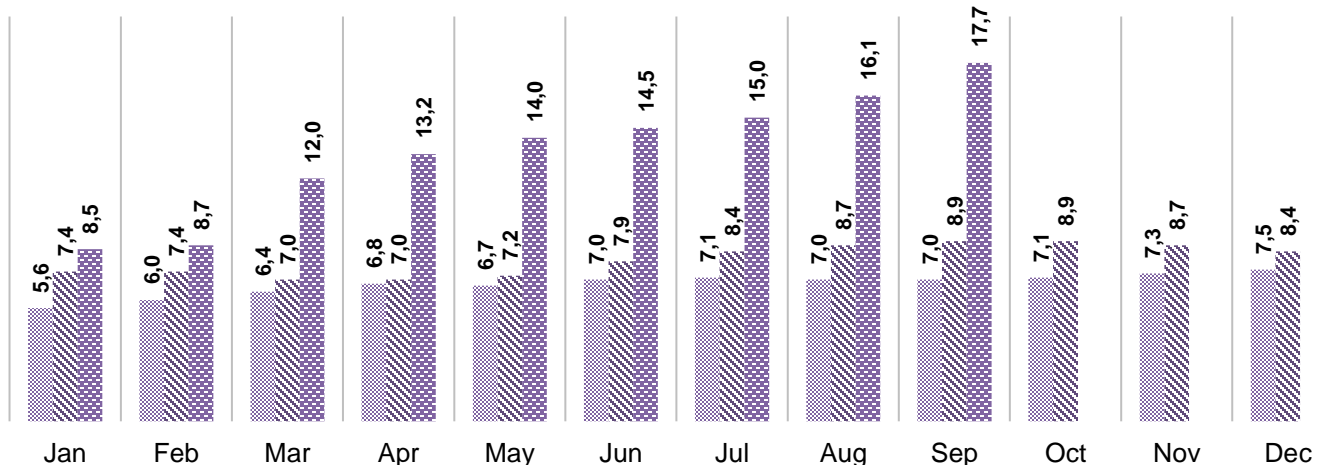

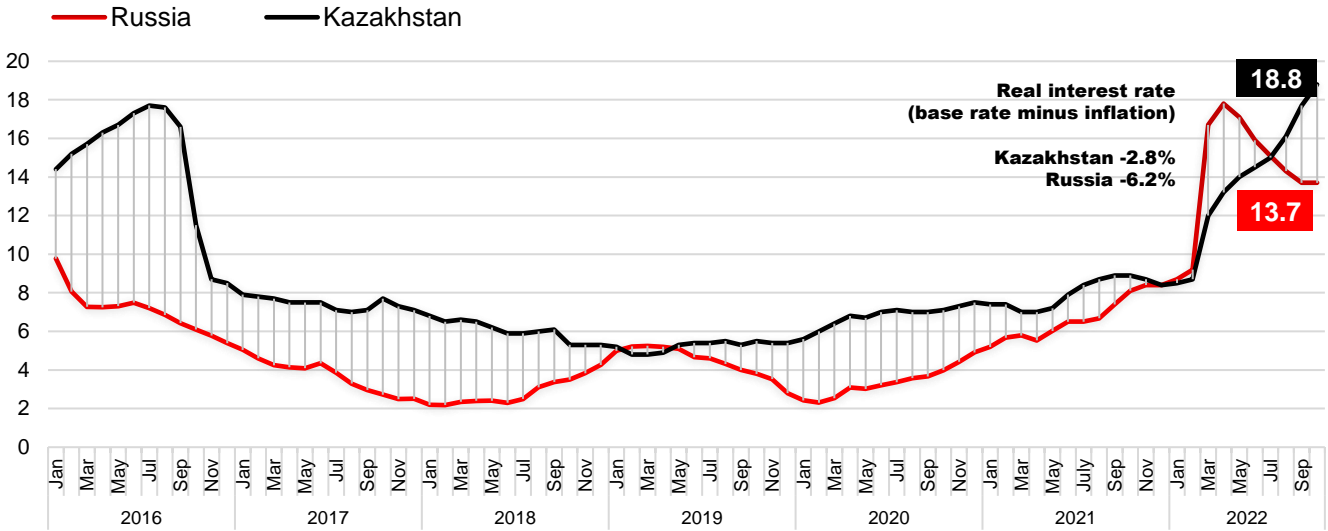

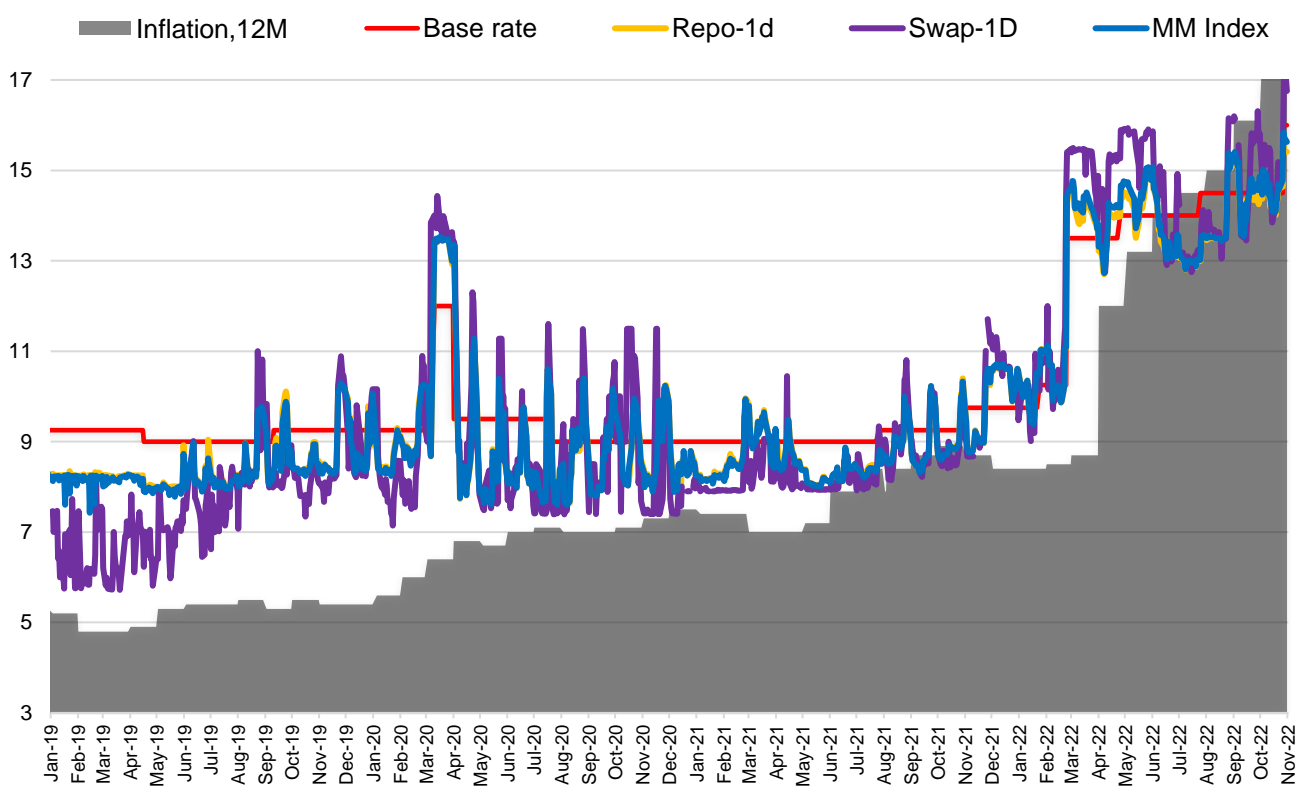

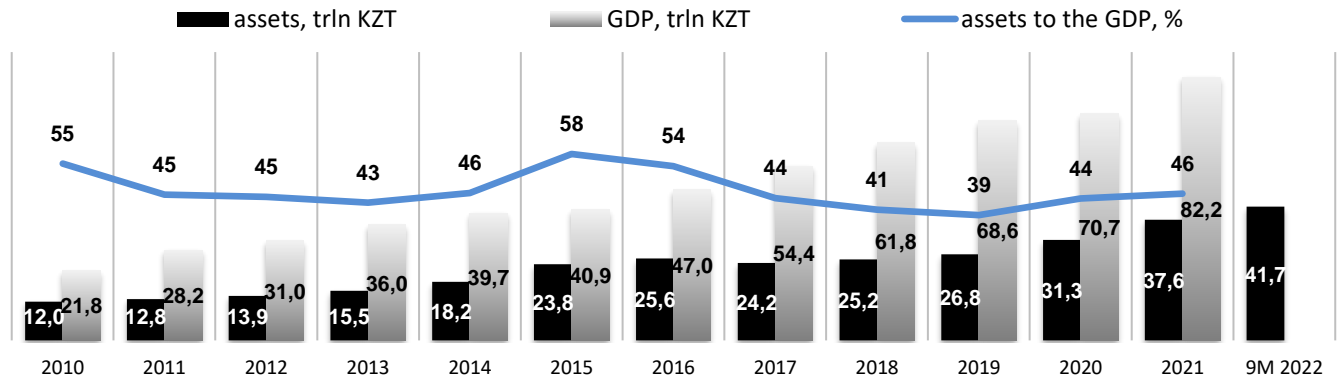

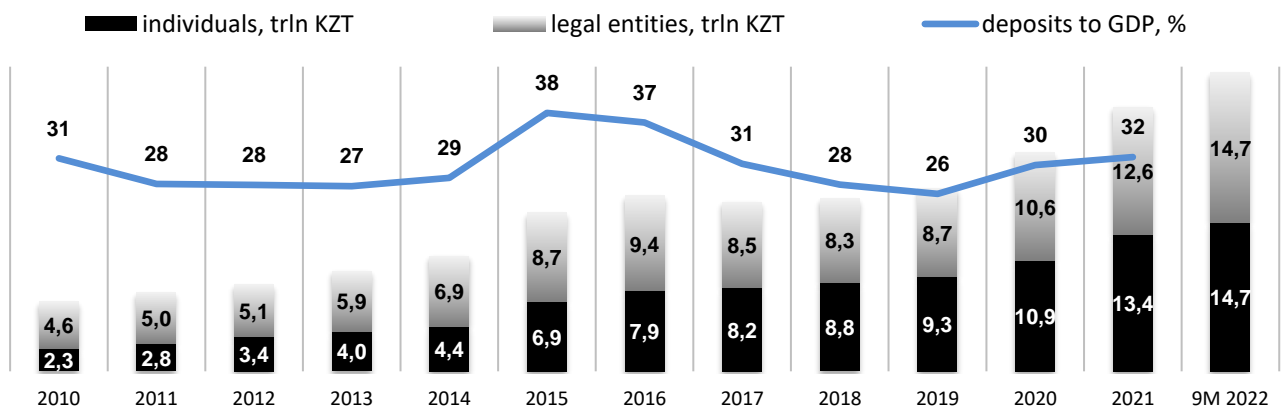
Assets of second tier banks



Banks' loan portfolio



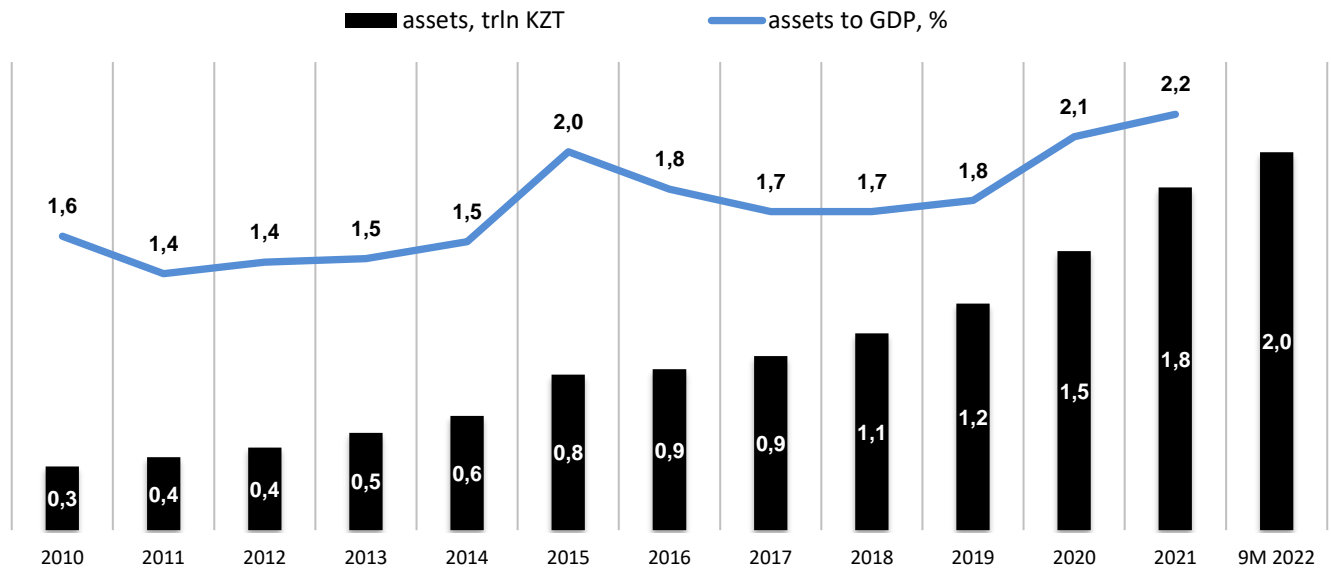
Banks' deposit portfolio



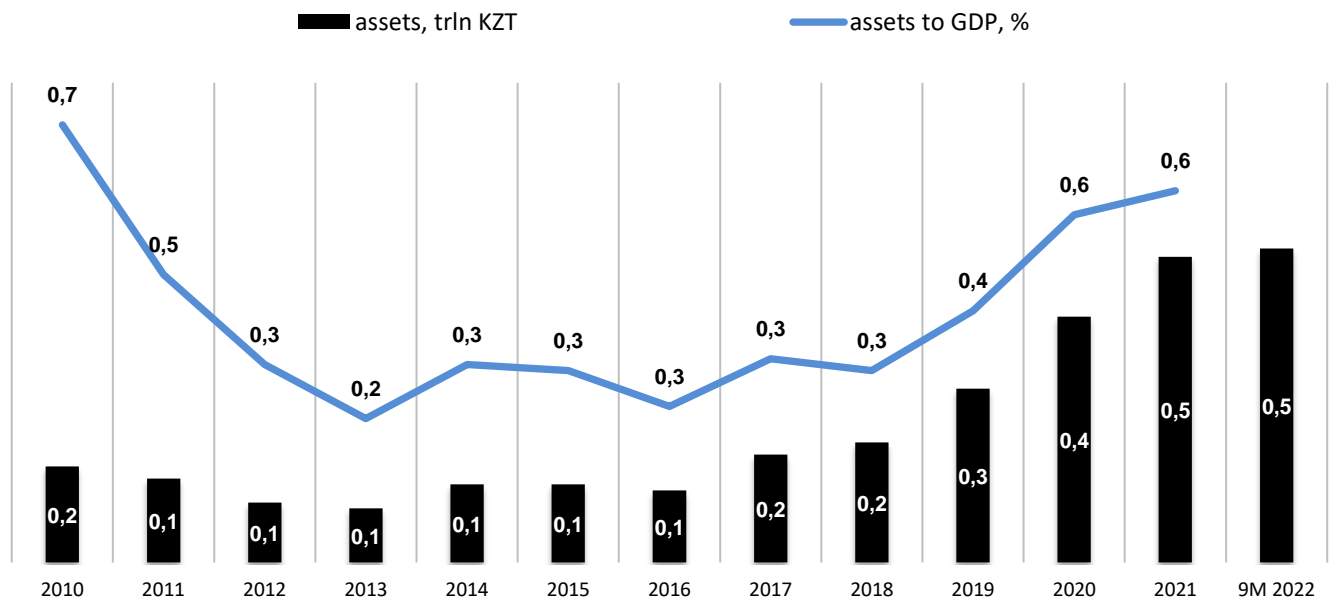

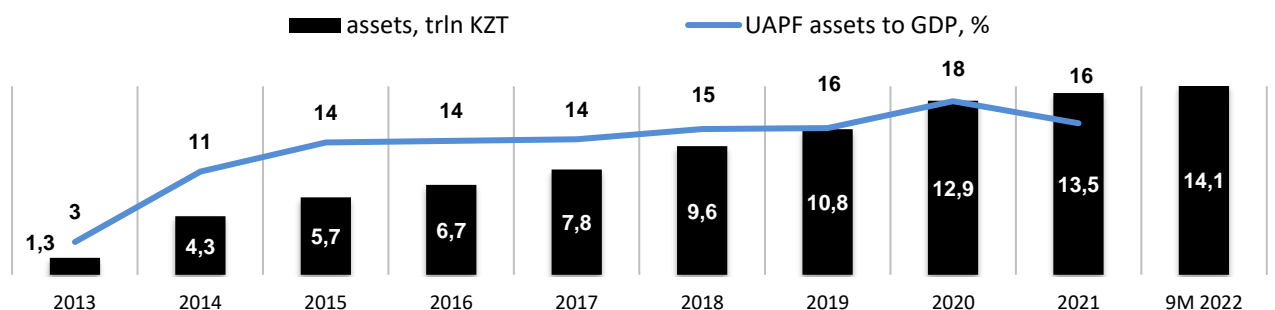

UAPF assets/GDP, %

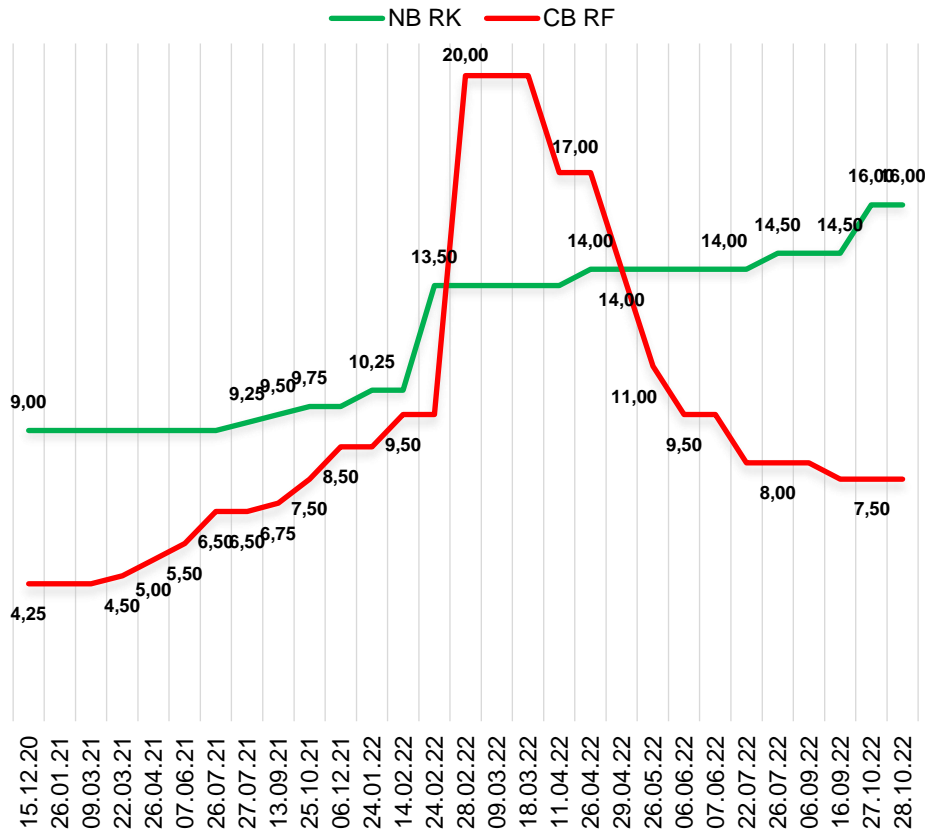

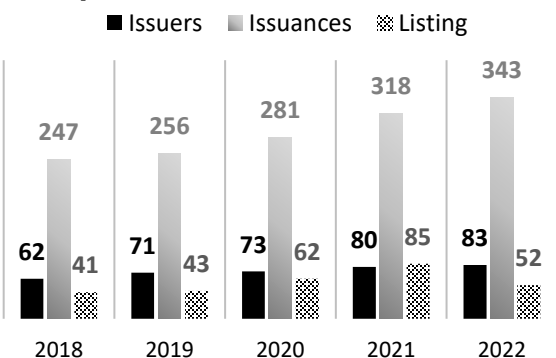

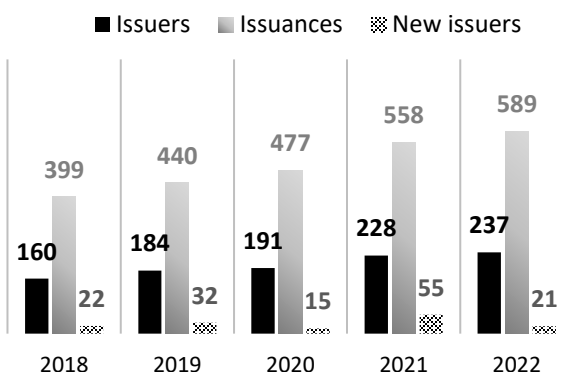

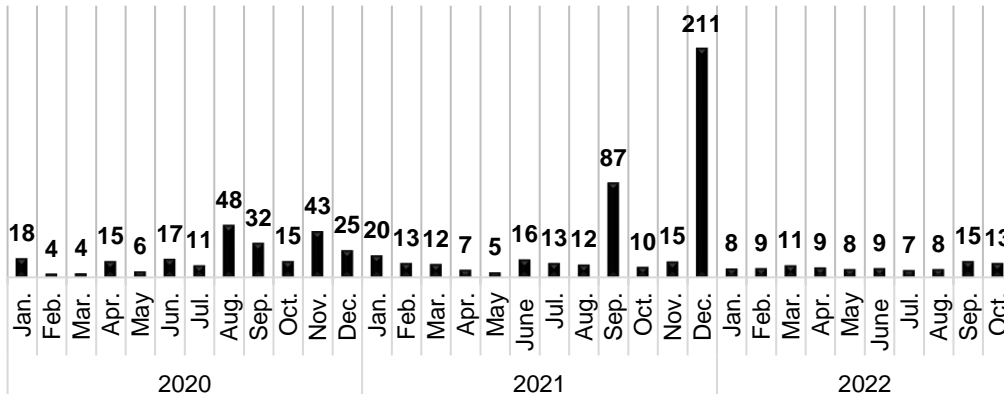

Dynamics of trading on the equity market monthly, bn KZT



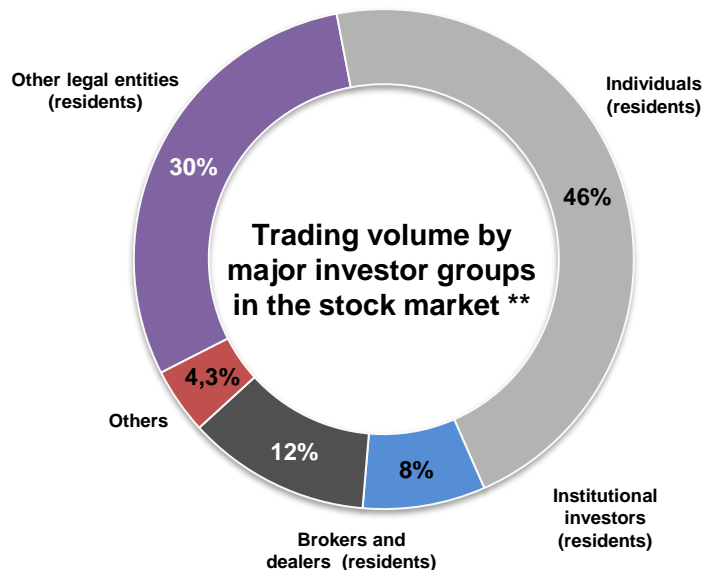
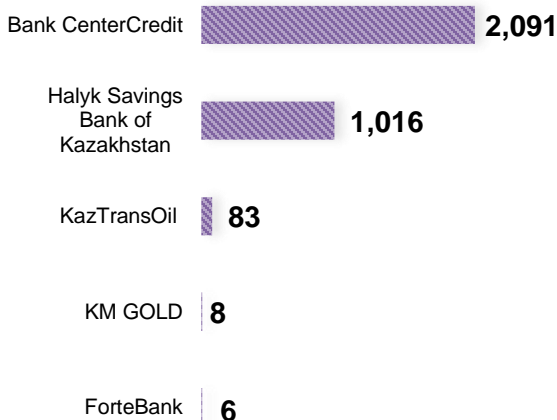
