Fitch Ratings upgraded ratings of JSC "Halyk Bank"

On 23 January 2013, the international rating agency Fitch Ratings (hereinafter – Fitch) announced the upgrade of Long-Term Issuer Default Ratings (hereinafter – IDRs) of JSC "Halyk Bank" (hereinafter the "Bank" or "Halyk Bank") to 'BB' from 'BB-' and removed the ratings from Rating Watch Evolving (RWE).
