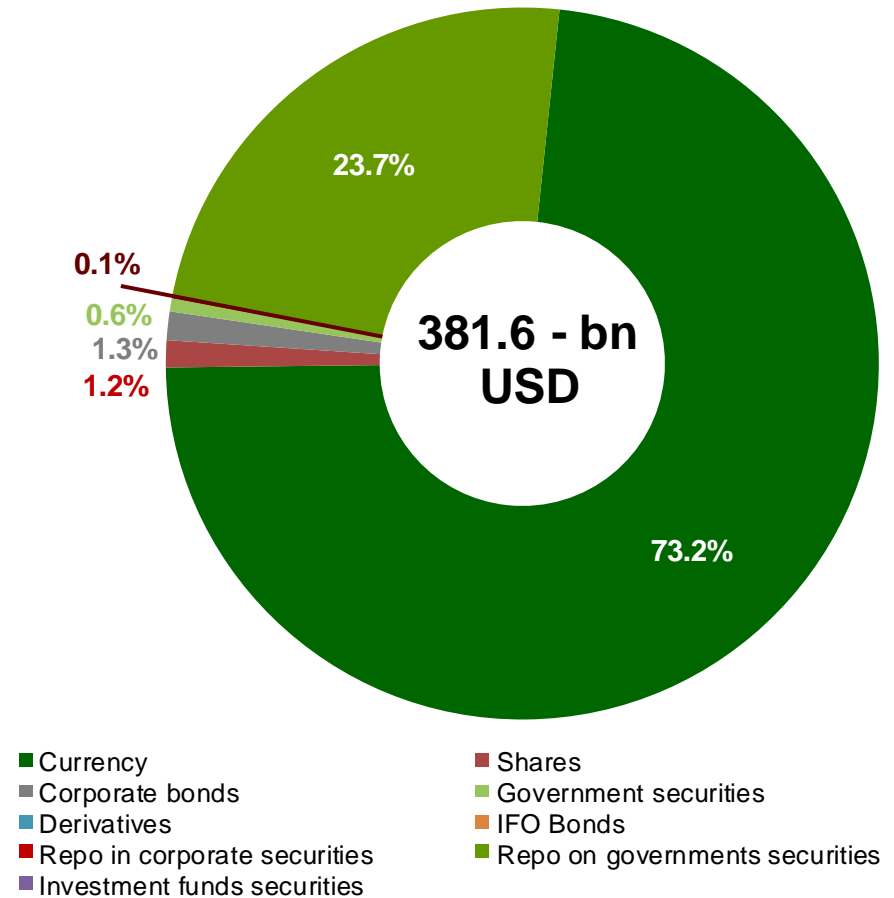

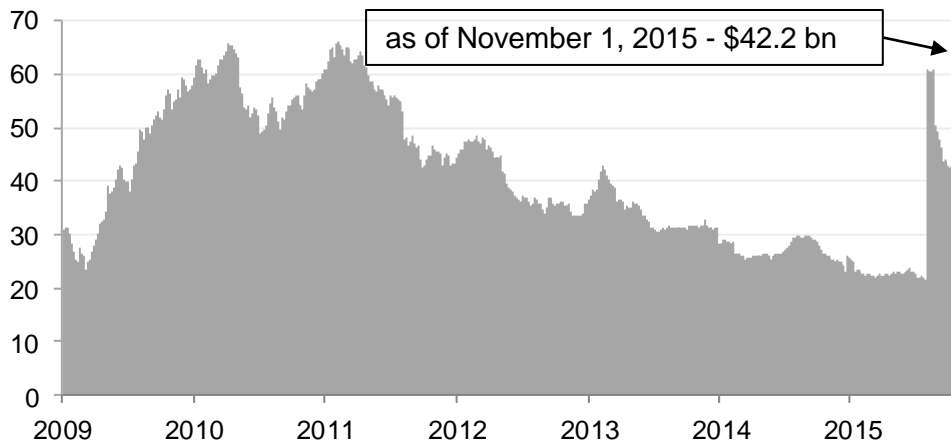

Volume Traded and GDP

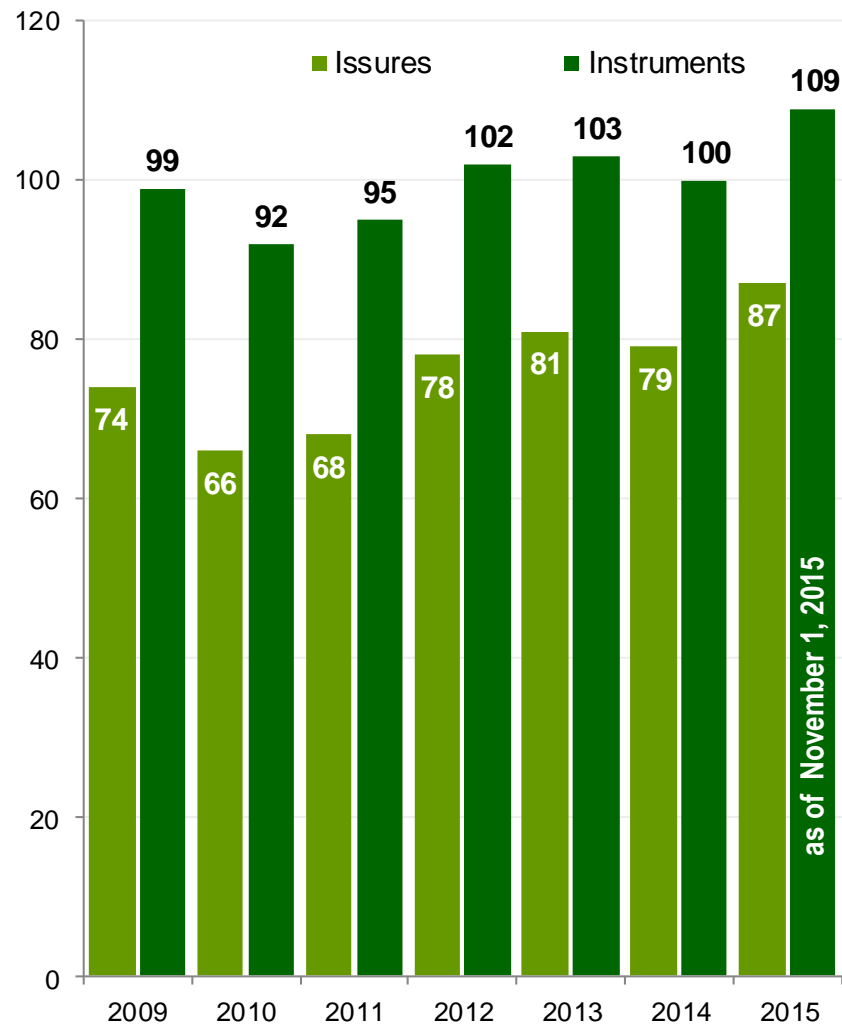
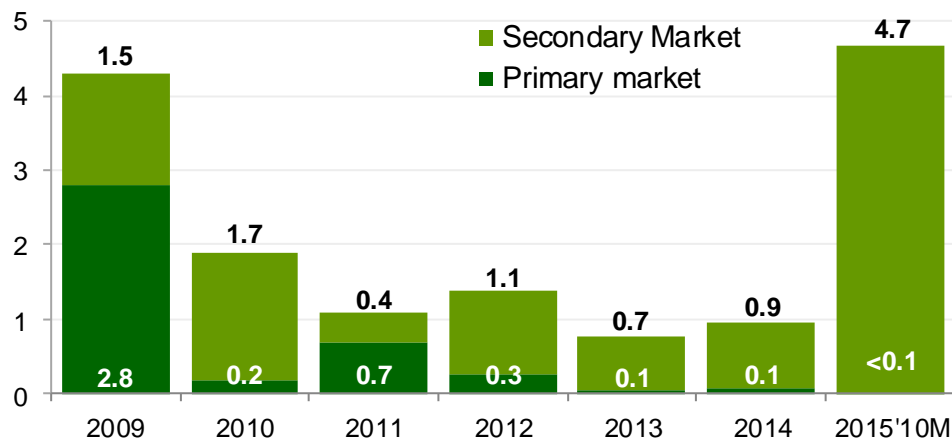


Share Market

Capitalization, USD bn

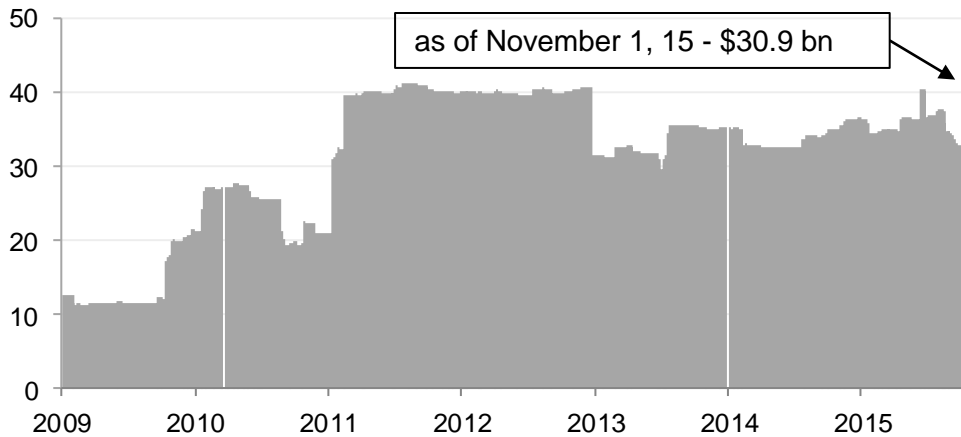


Traded volume, USD bn

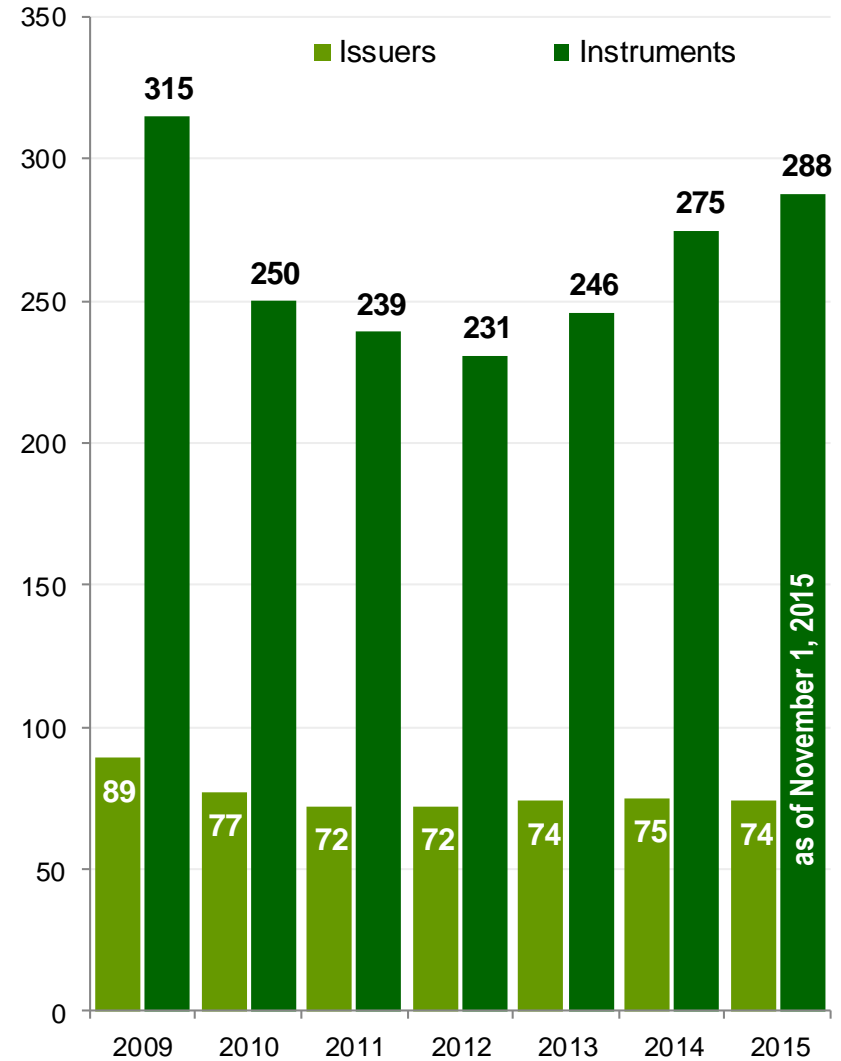
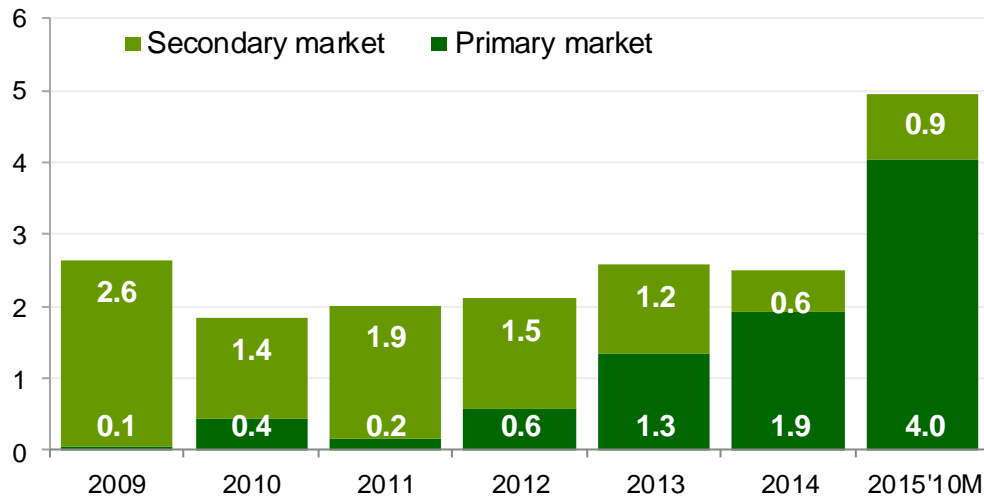


Corporate Bonds Market

Capitalization, USD bn

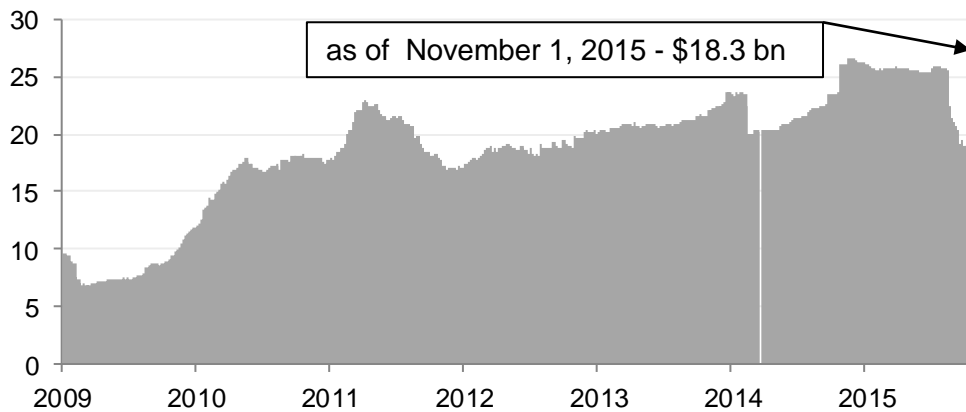


Traded value, USD bn

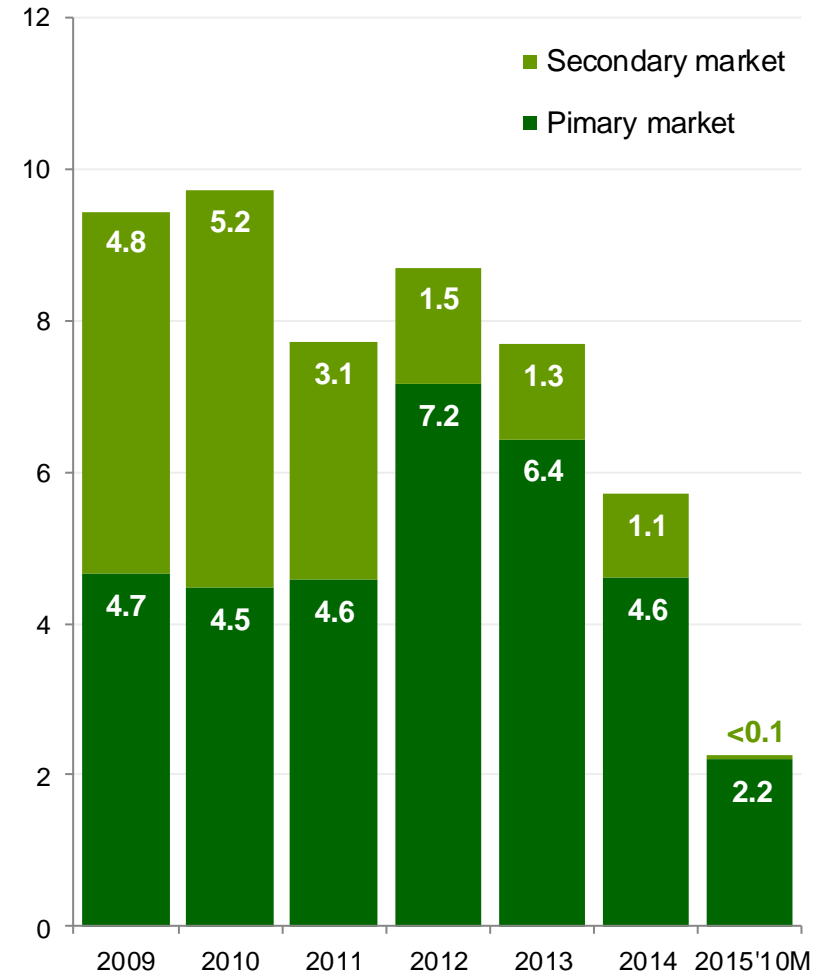


Government Securities Market

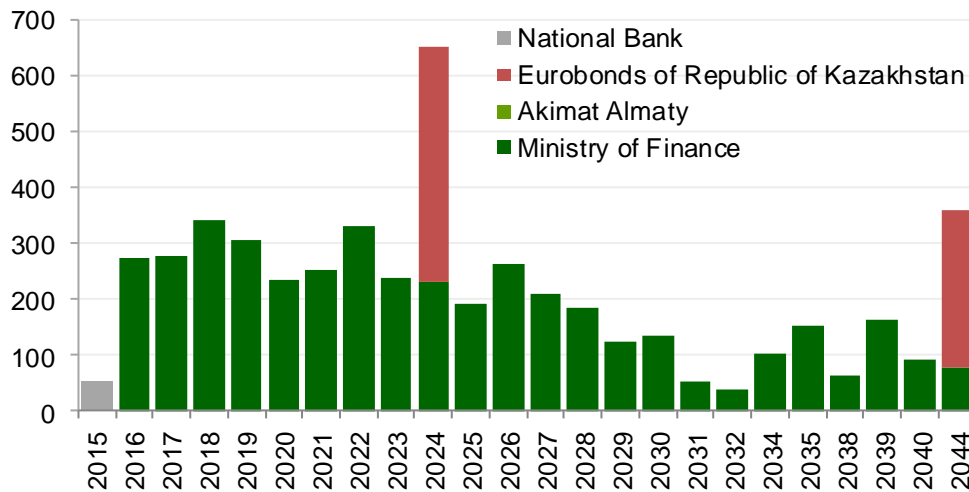
Volume of public sector debt, USD bn

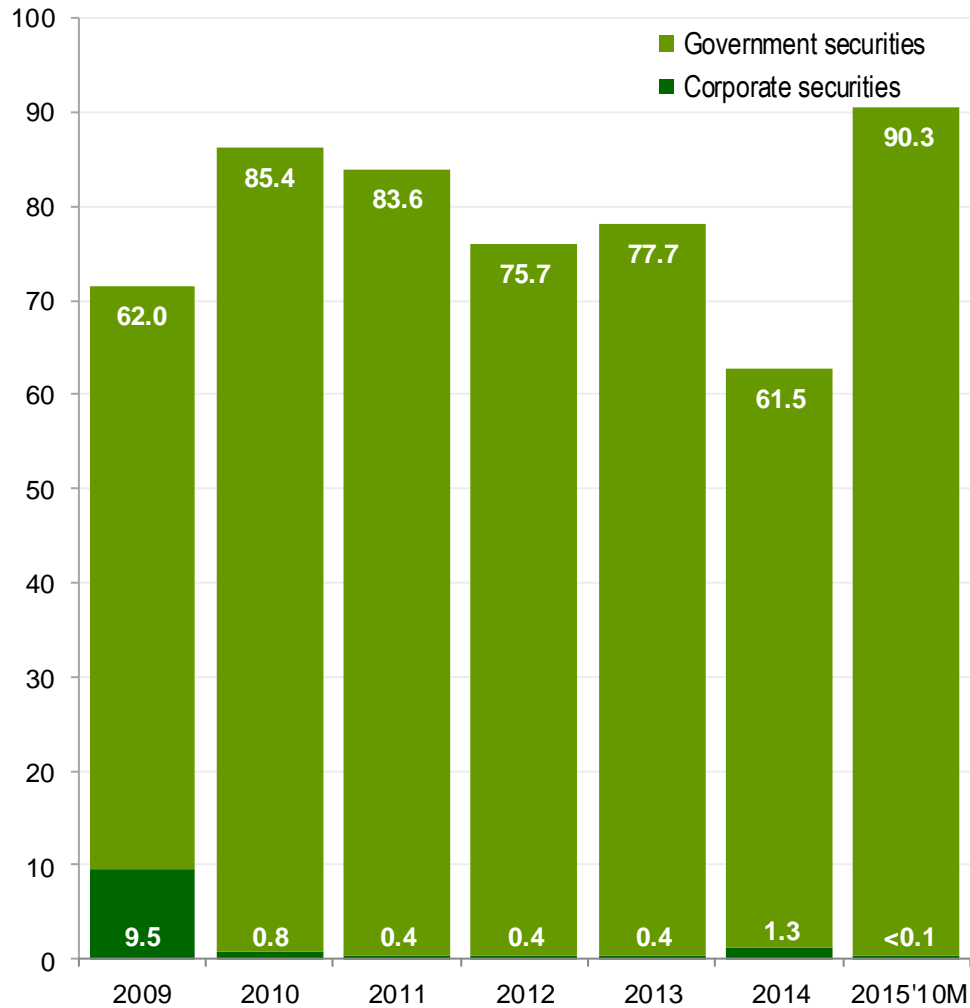


Public sector debt disbursements dynamics, KZT bn

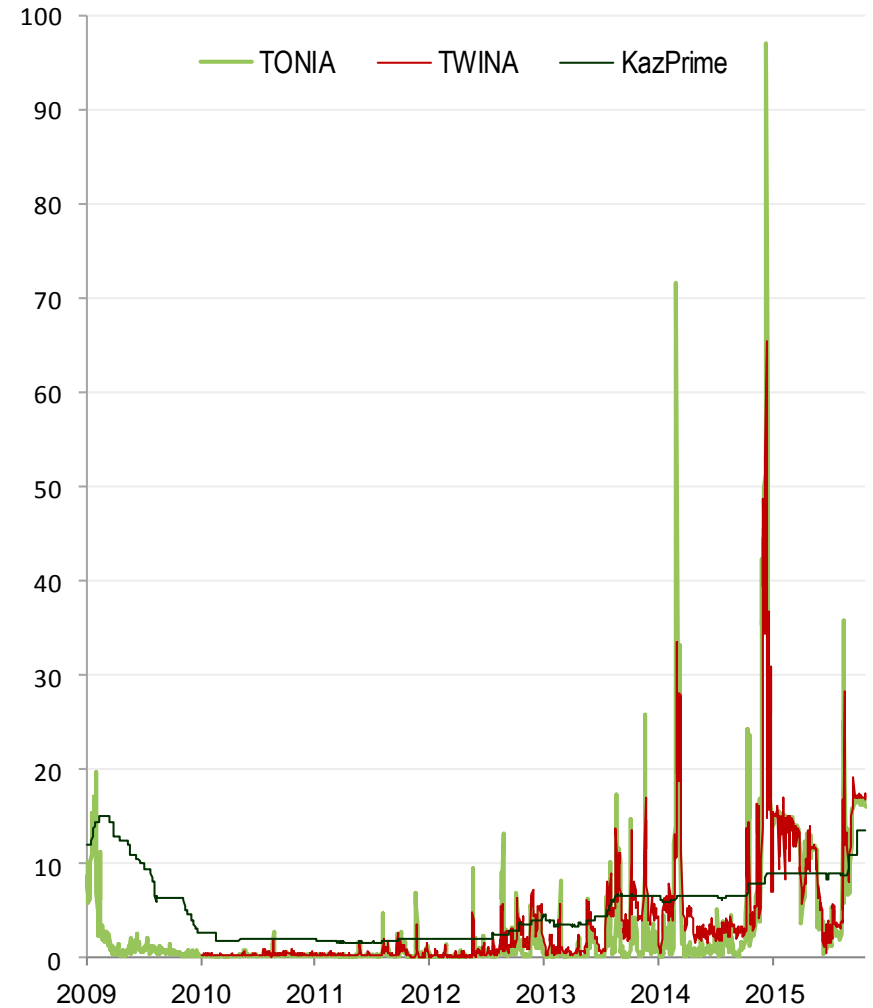


Repo Transactions Market

Traded volume, USD bn



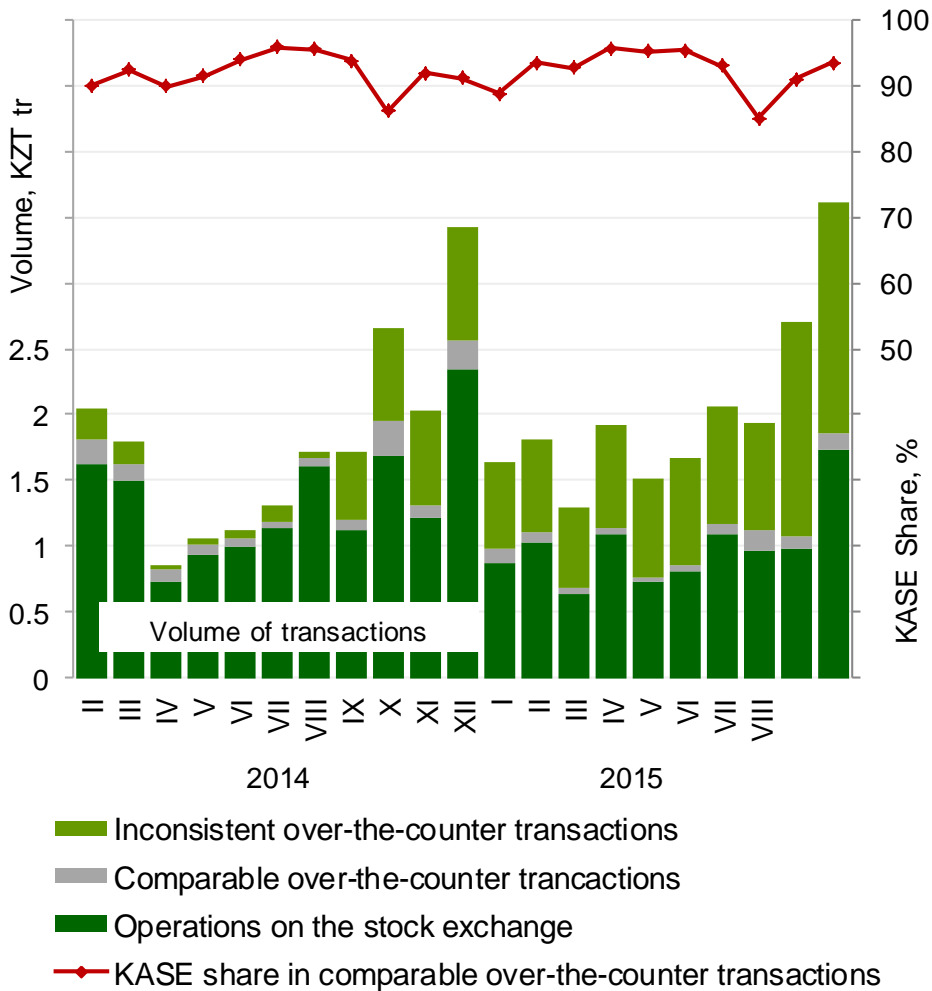

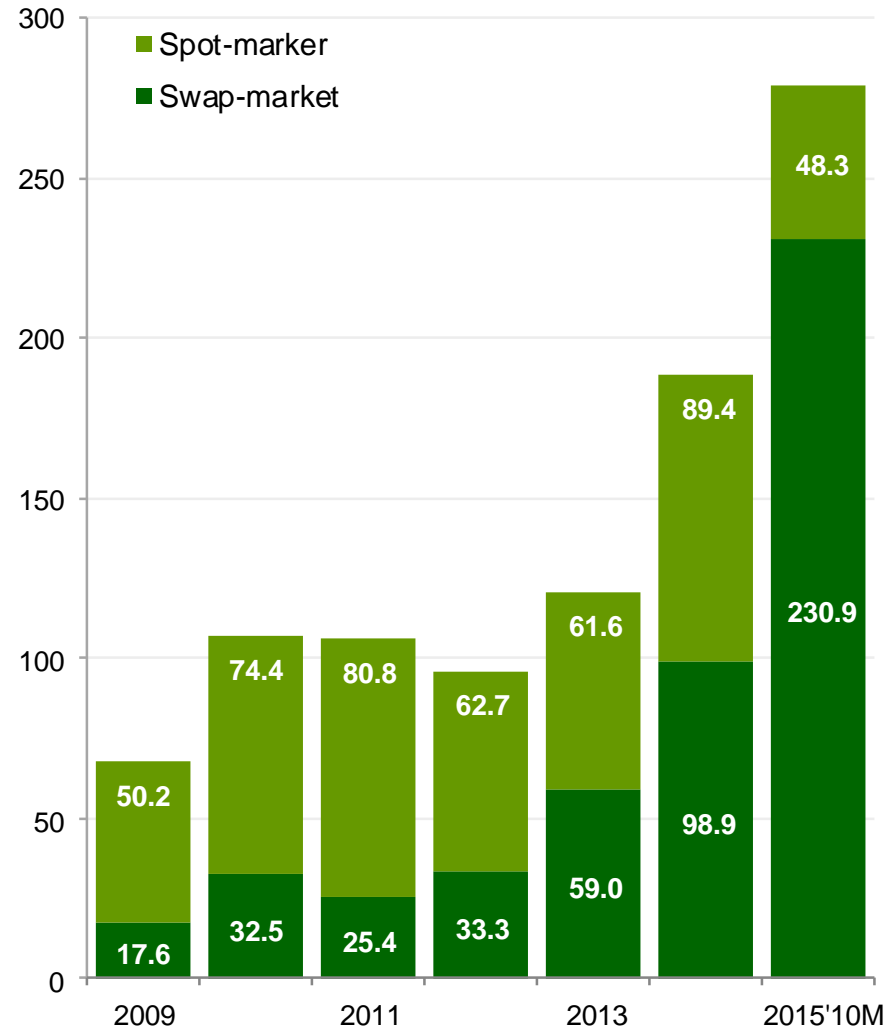

Sectoral structure of the market turnover and KASE share

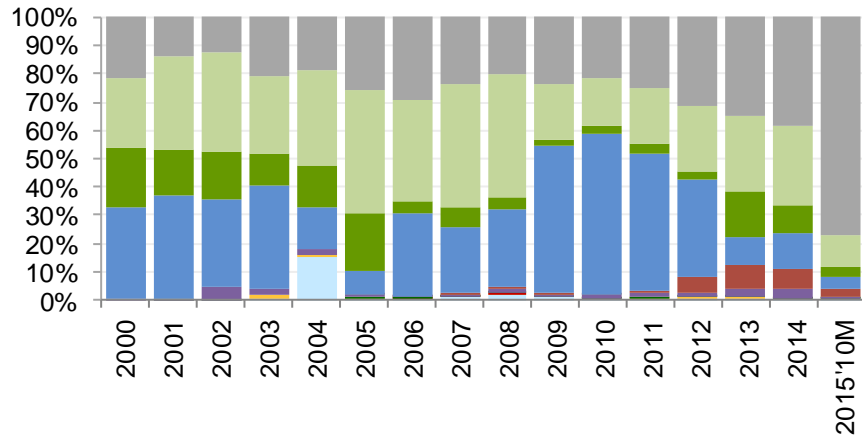



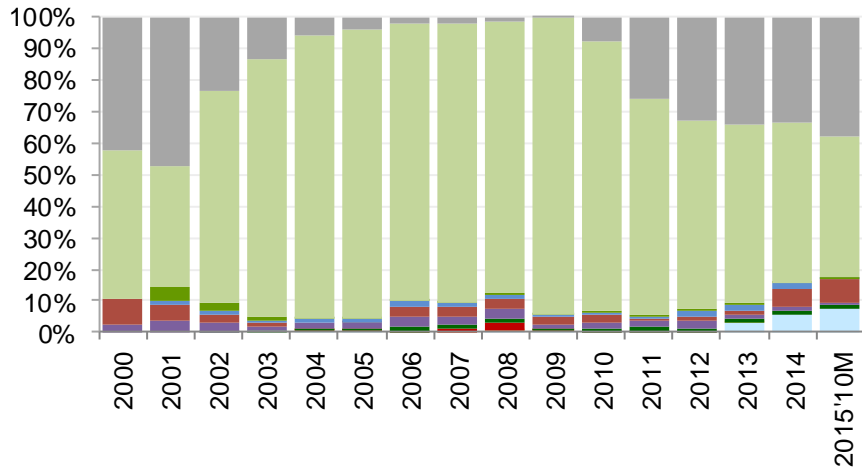
