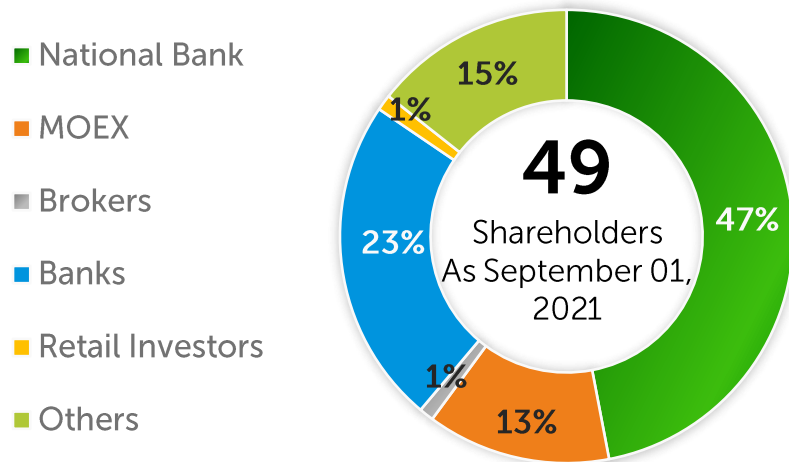


## Kazakhstan Stock Exchange

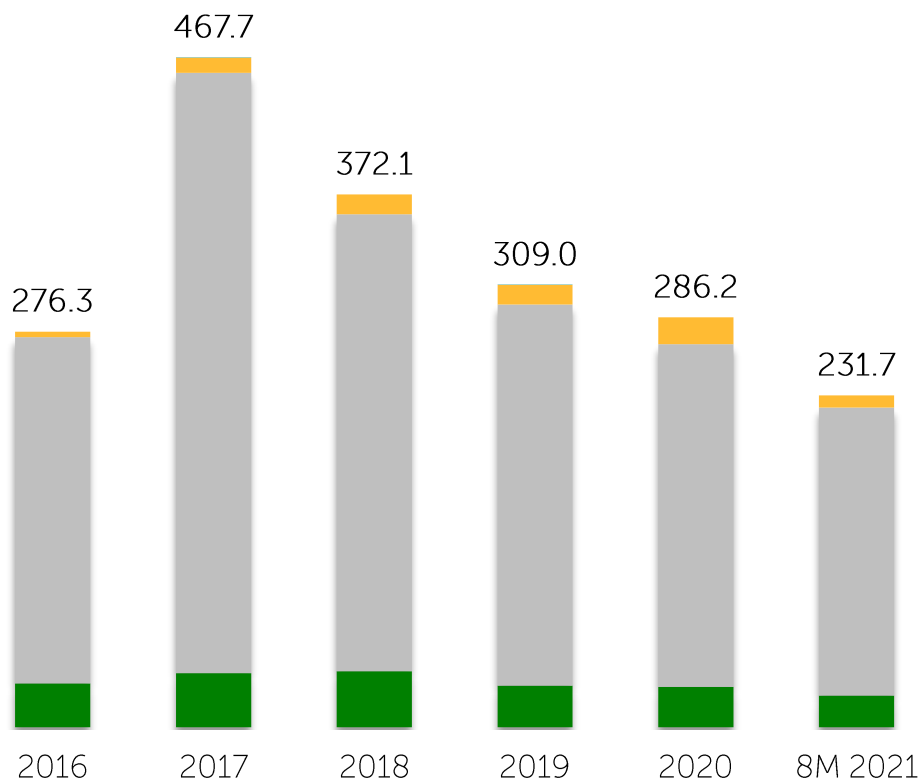

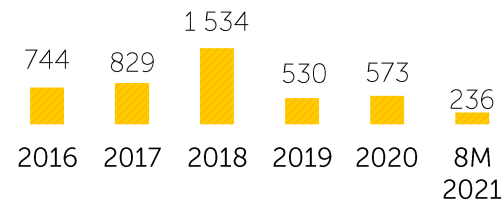

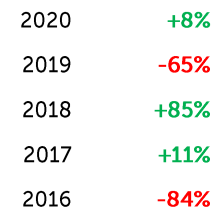
Trading volume dynamics by sector, USD bn



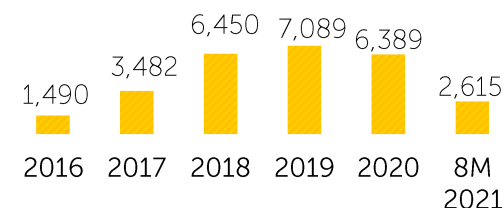

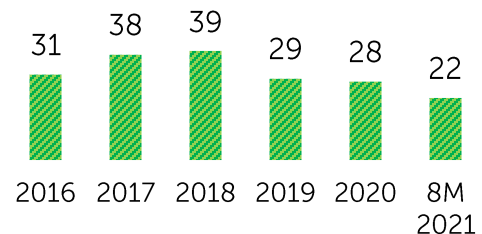

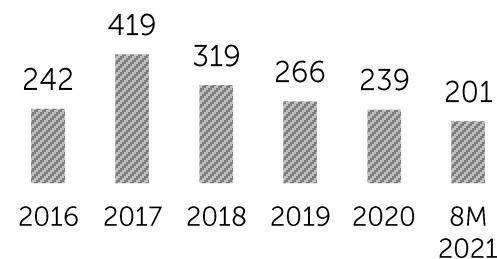

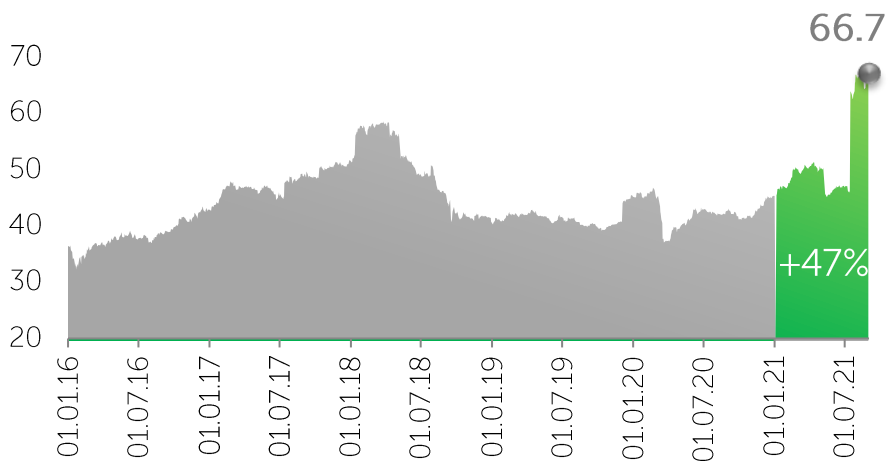

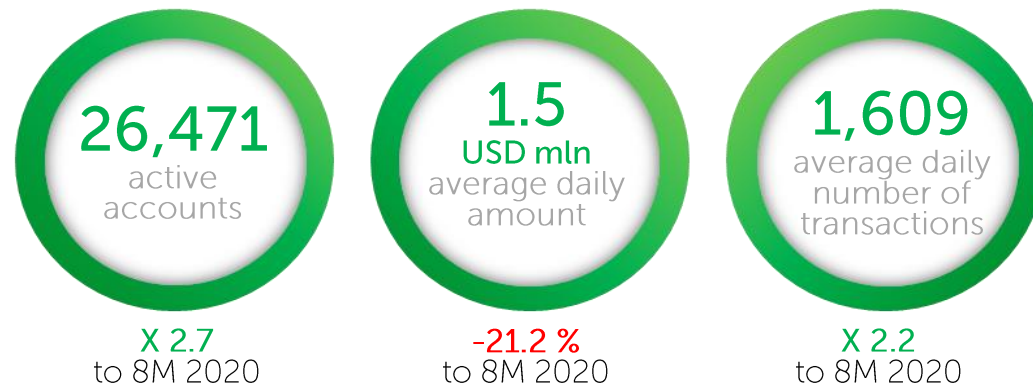

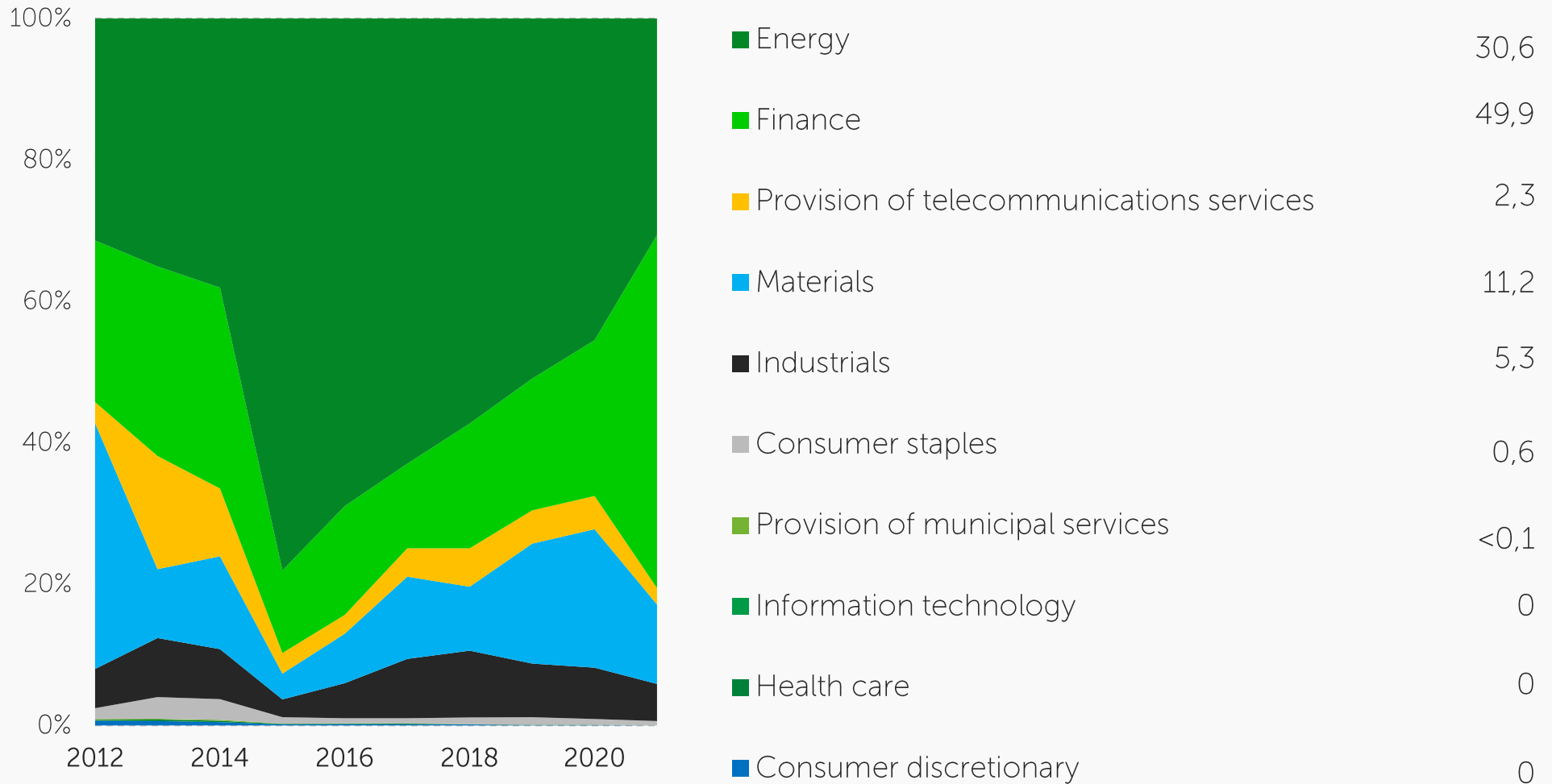

Share in total market cap, %

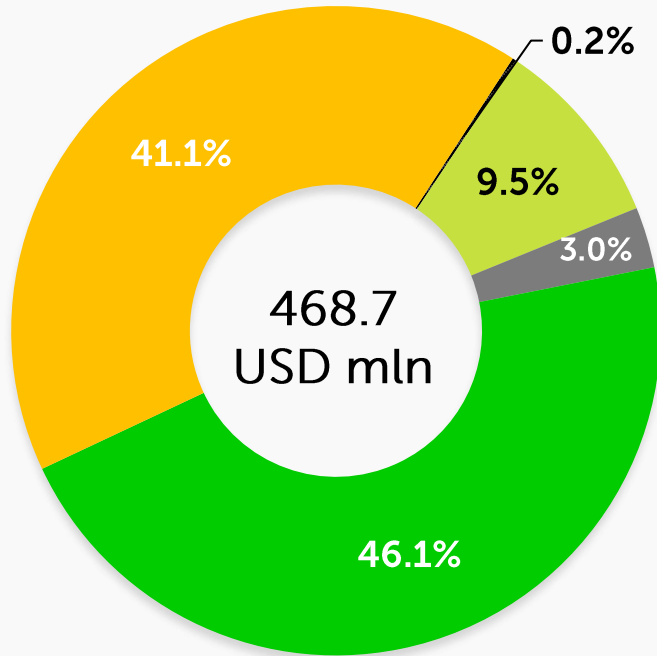

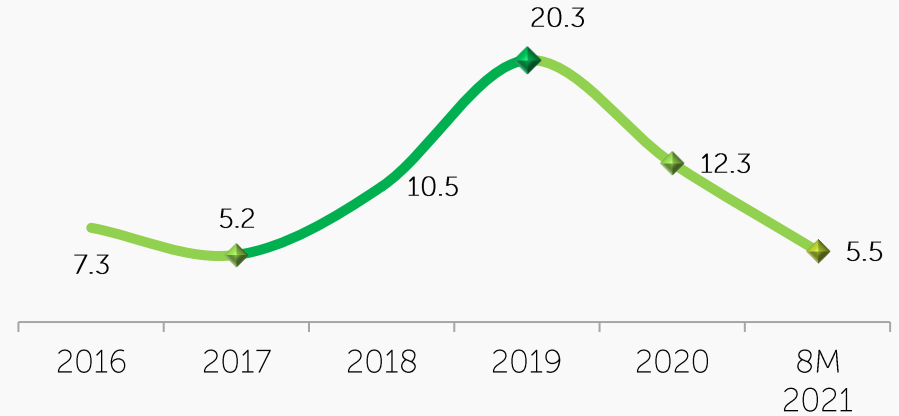

Main investor categories on the secondary market in 8M 2021\*

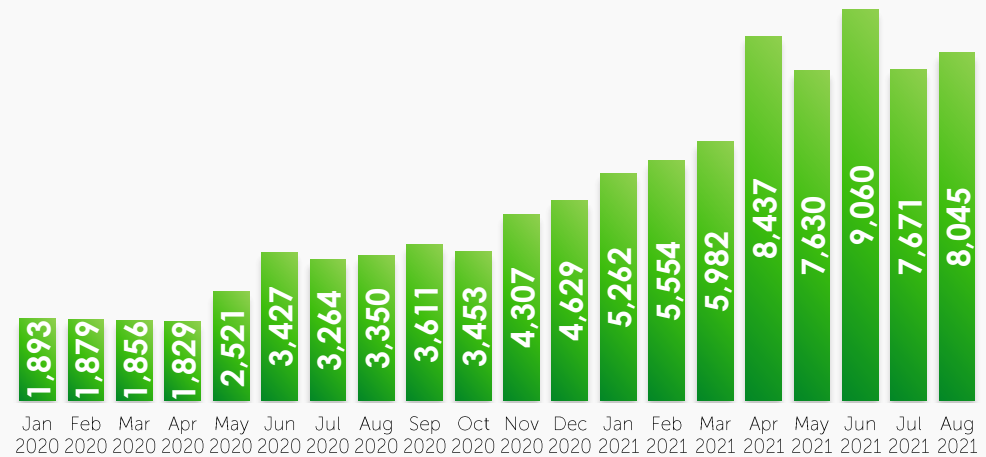

Non-residents in the gross turnover. %



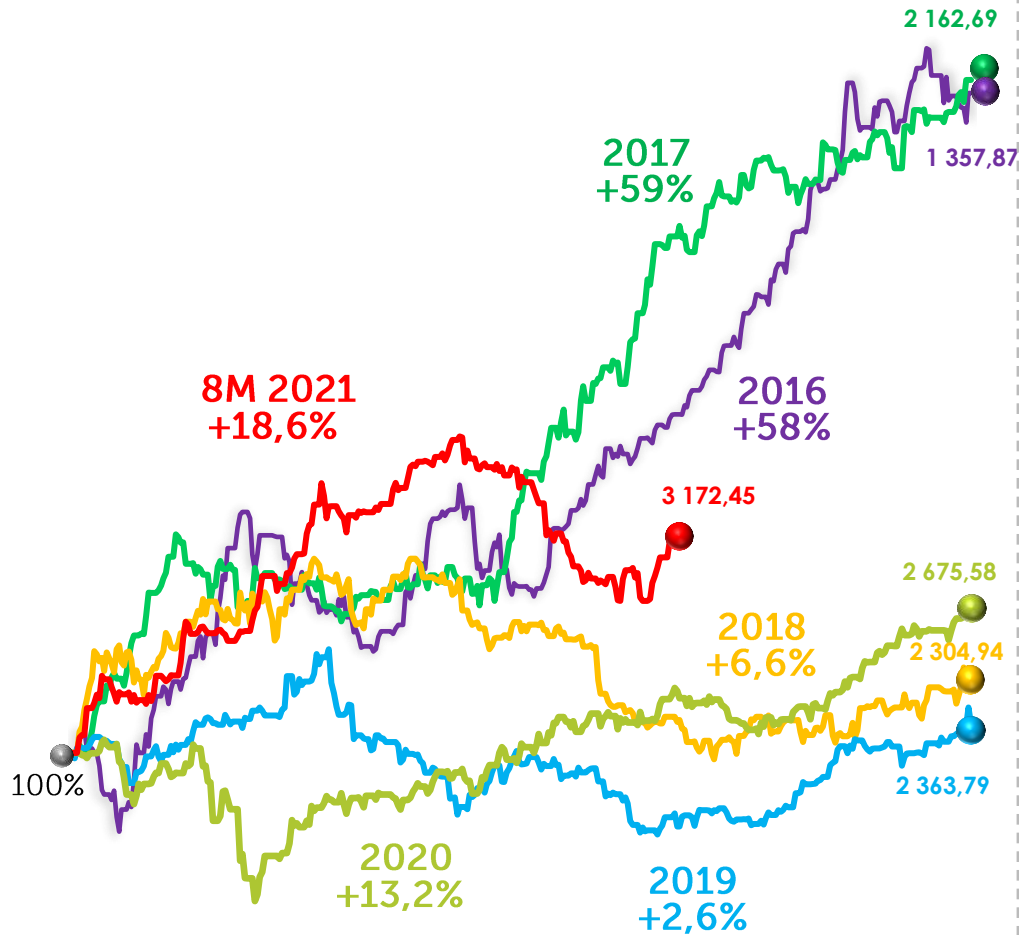
Dynamics of active accounts of retail investors on the equity market



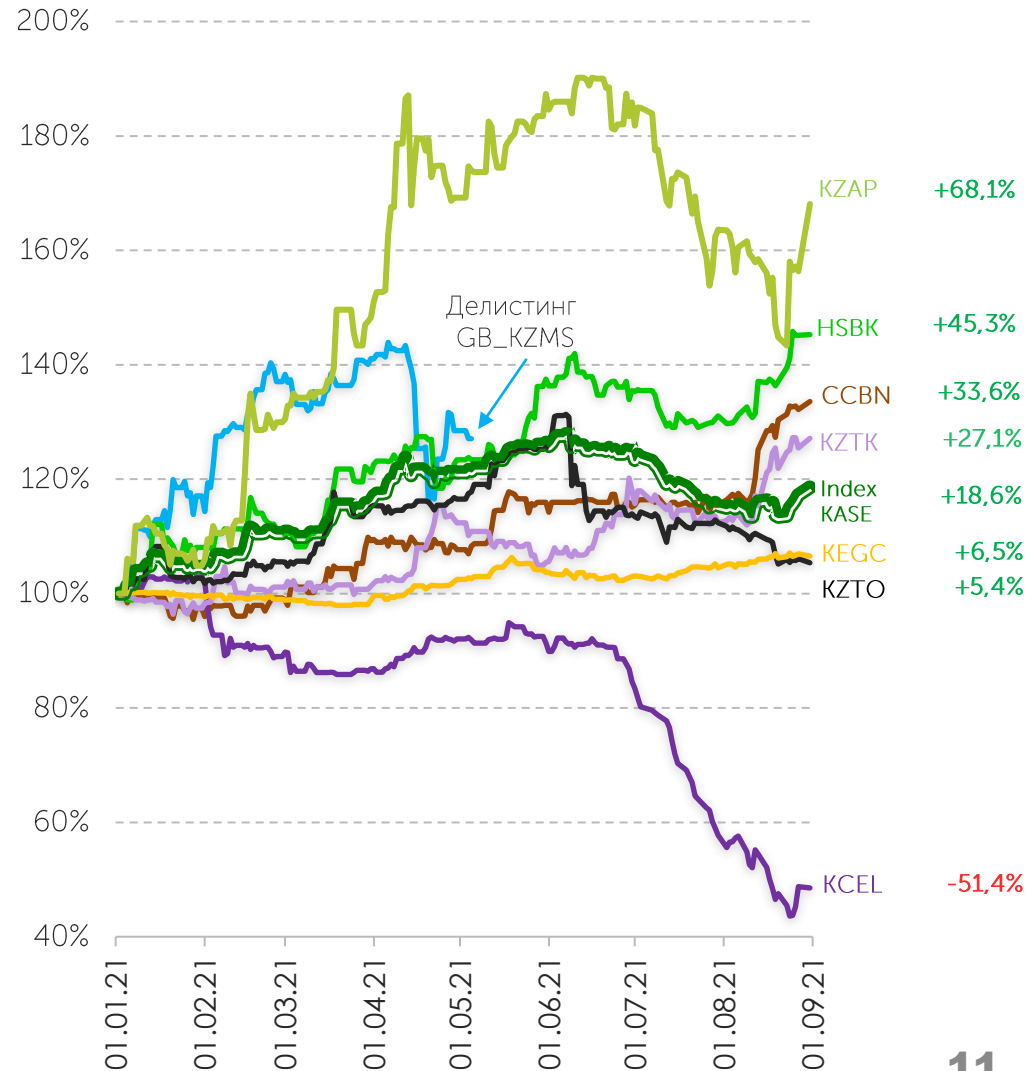

## KASE Index 2016- 8M 2021



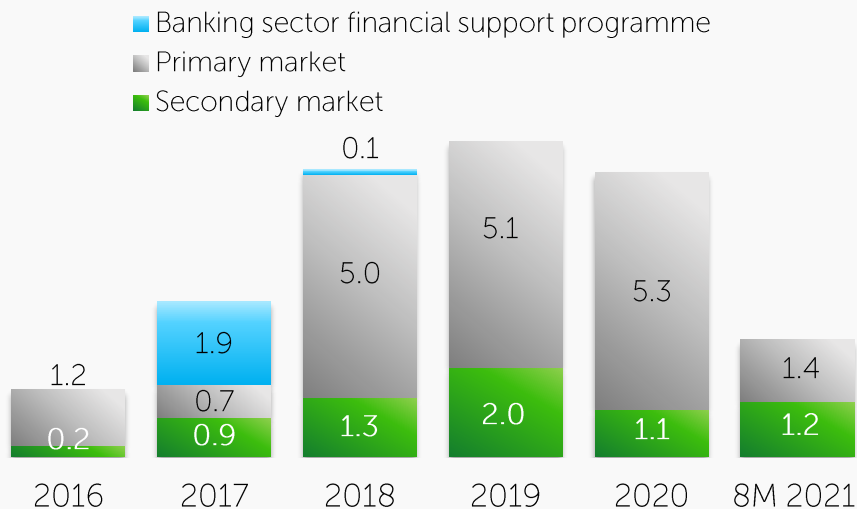

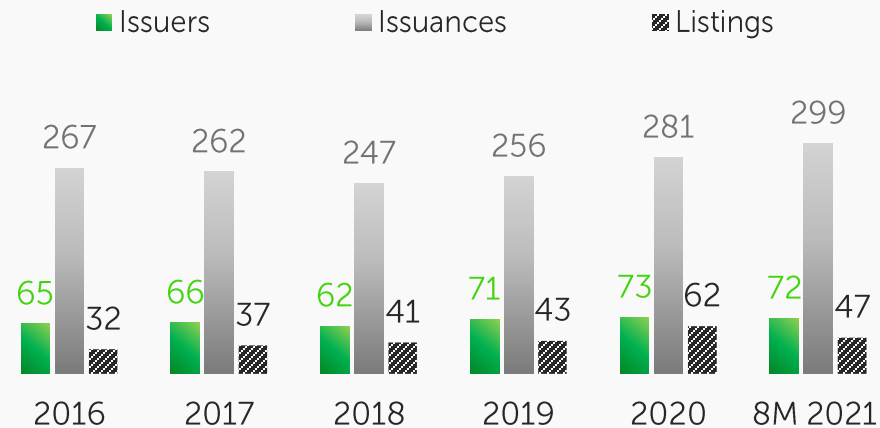

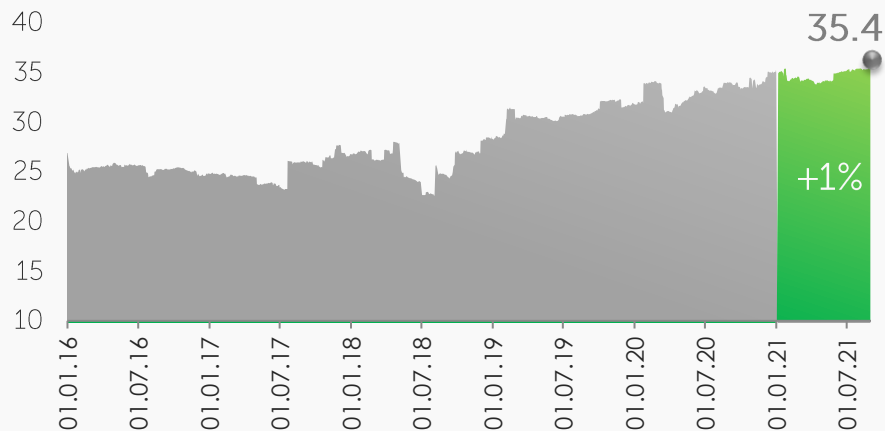

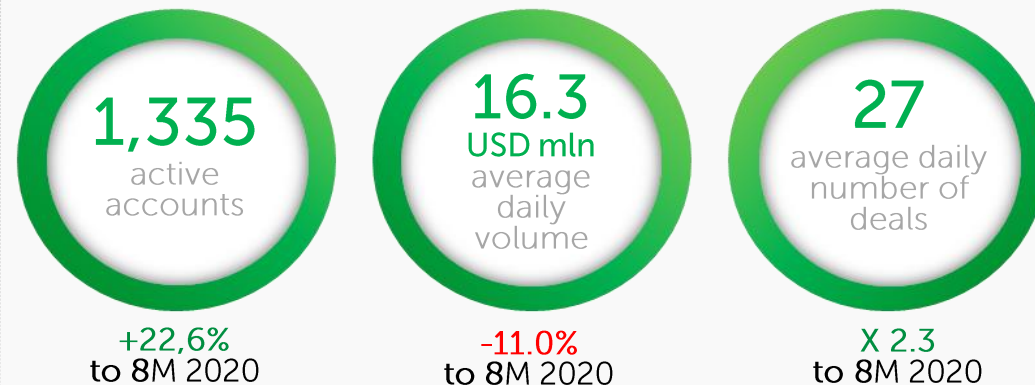

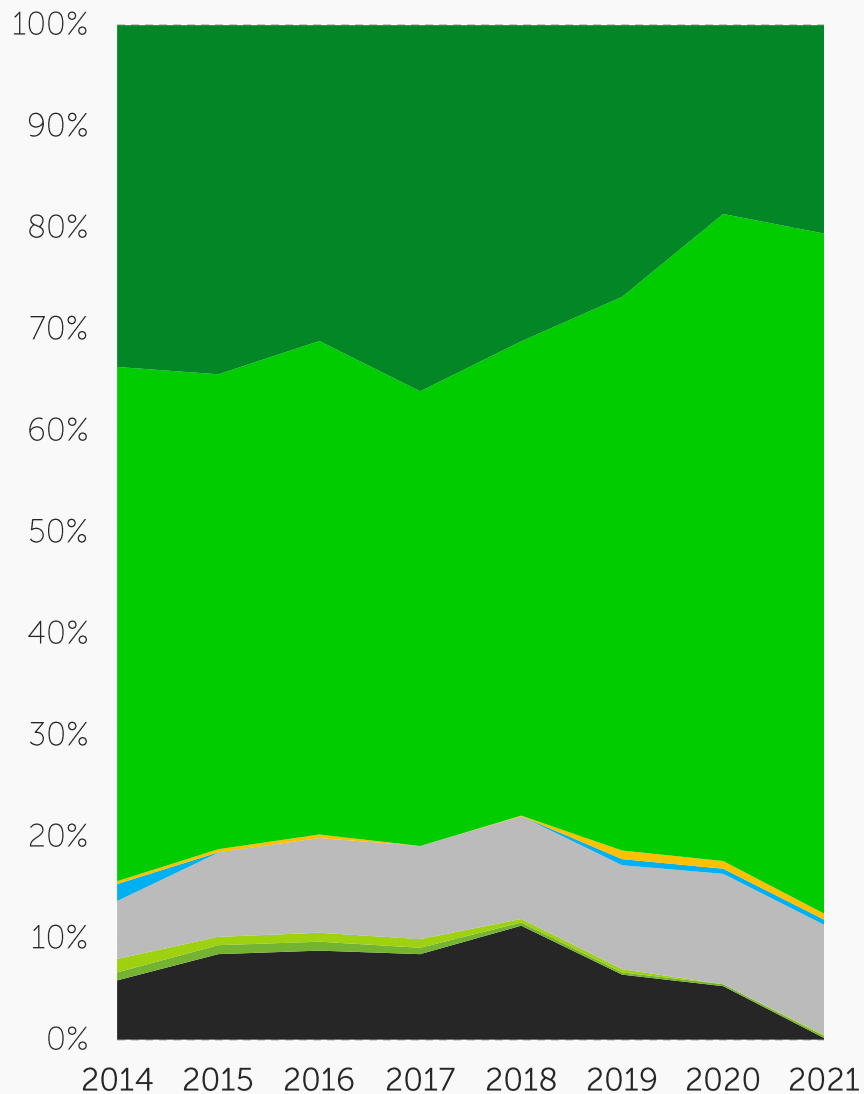
## Volume of outstanding corporate debt, USD bn

# Corporate bonds: Industry Structure

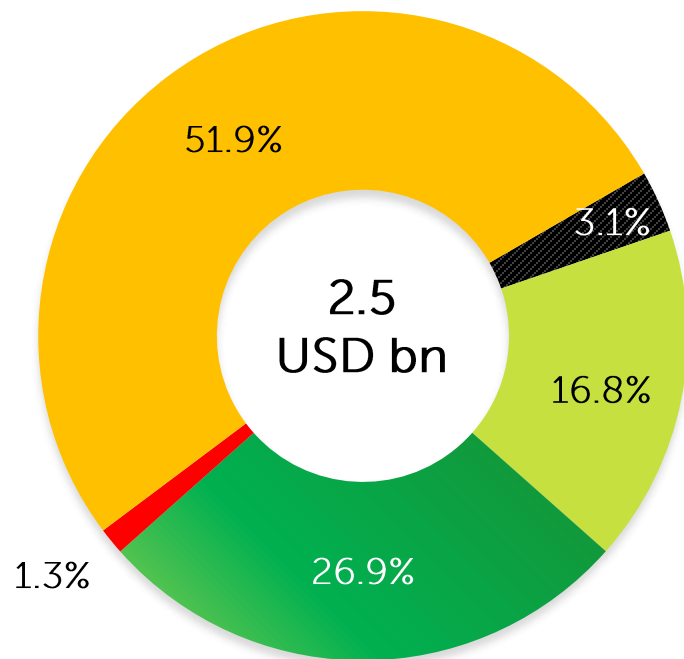

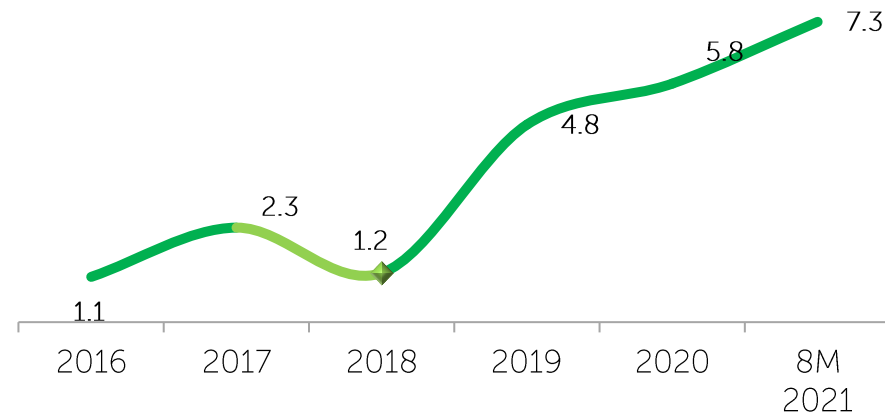

Main categories of investors on the secondary market in 8M 2021\*

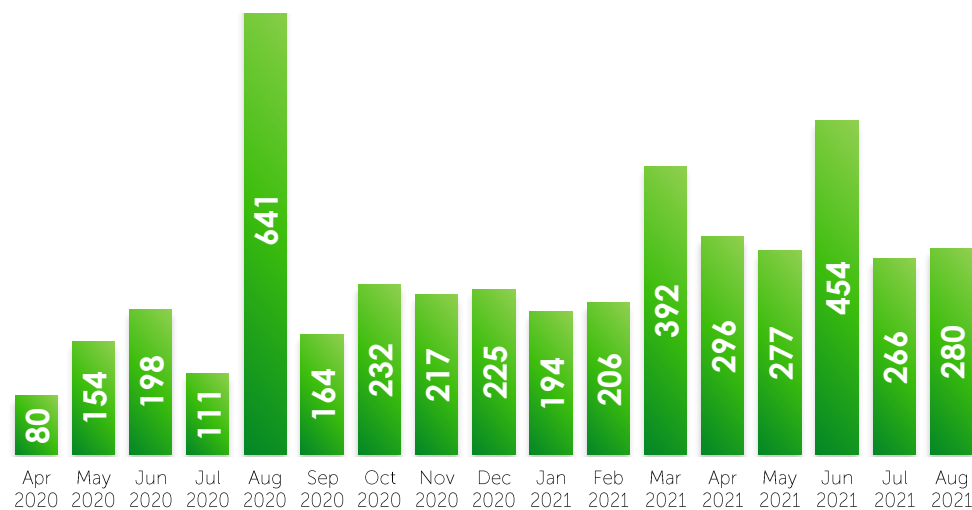

Dynamics of active accounts on the corporate bond market

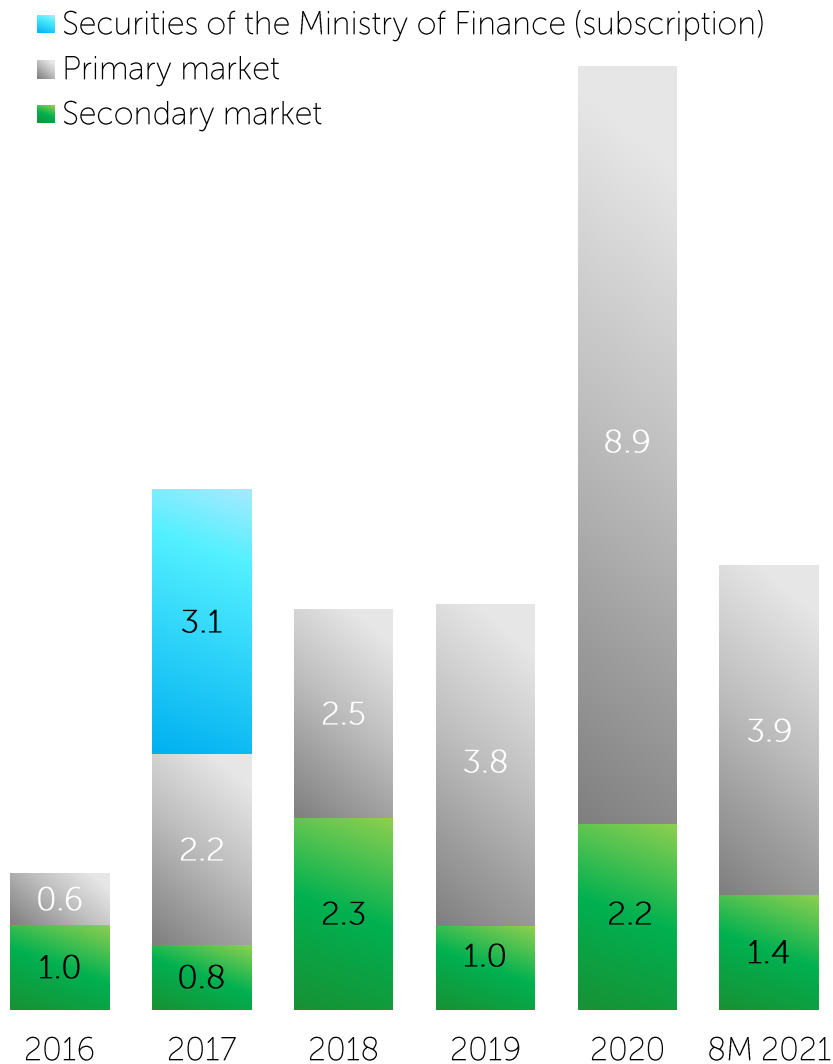

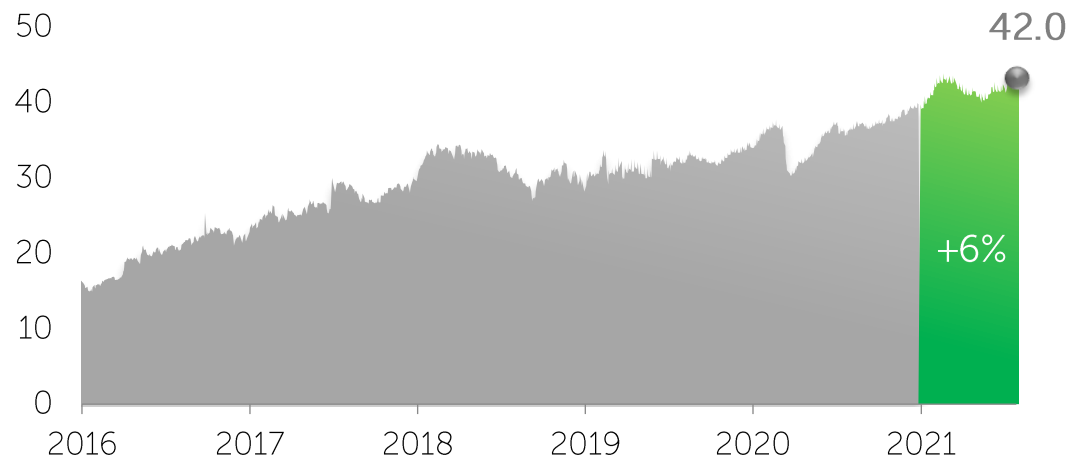

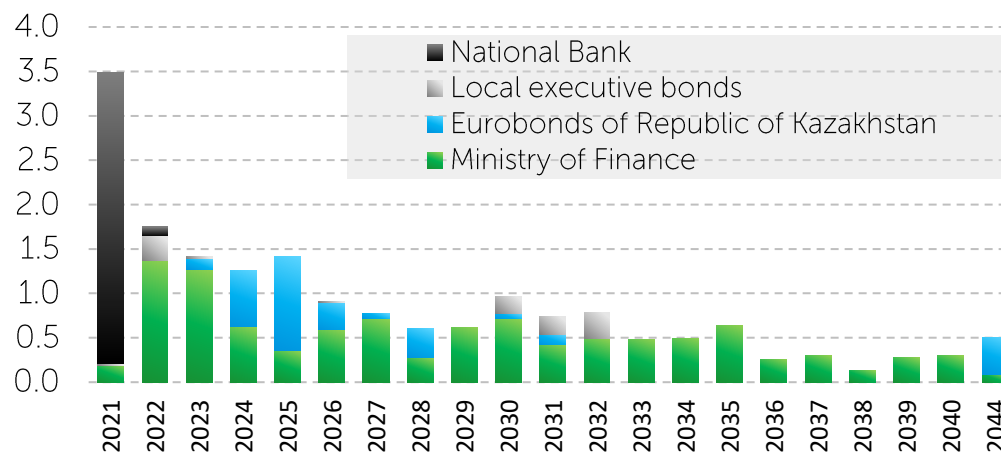
Trading volume dynamics, USD bn



Amount of government debt (at face value) traded on KASE, USD bn



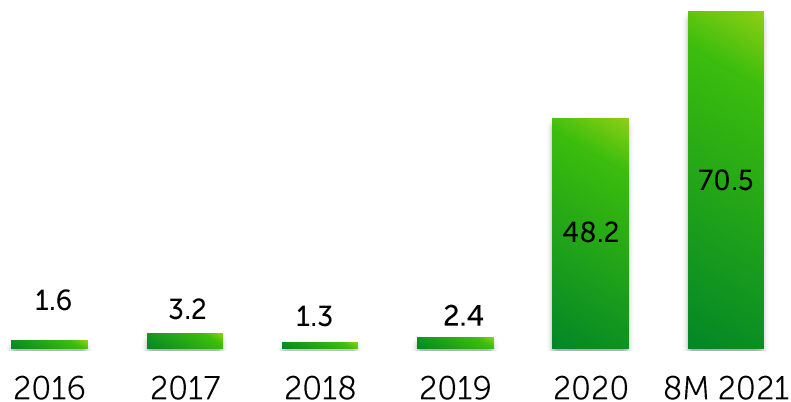
Public Debt Redemption, KZT trln



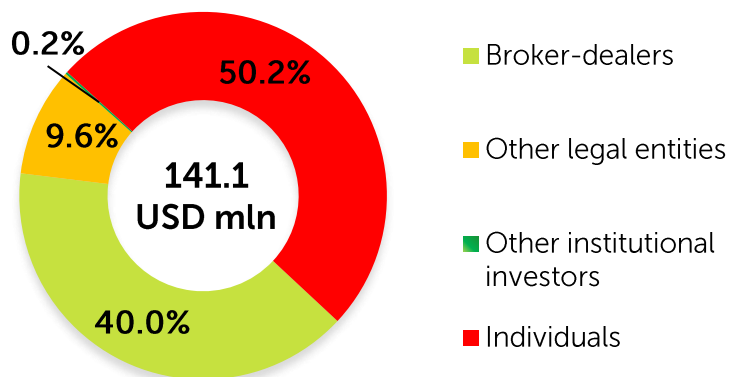

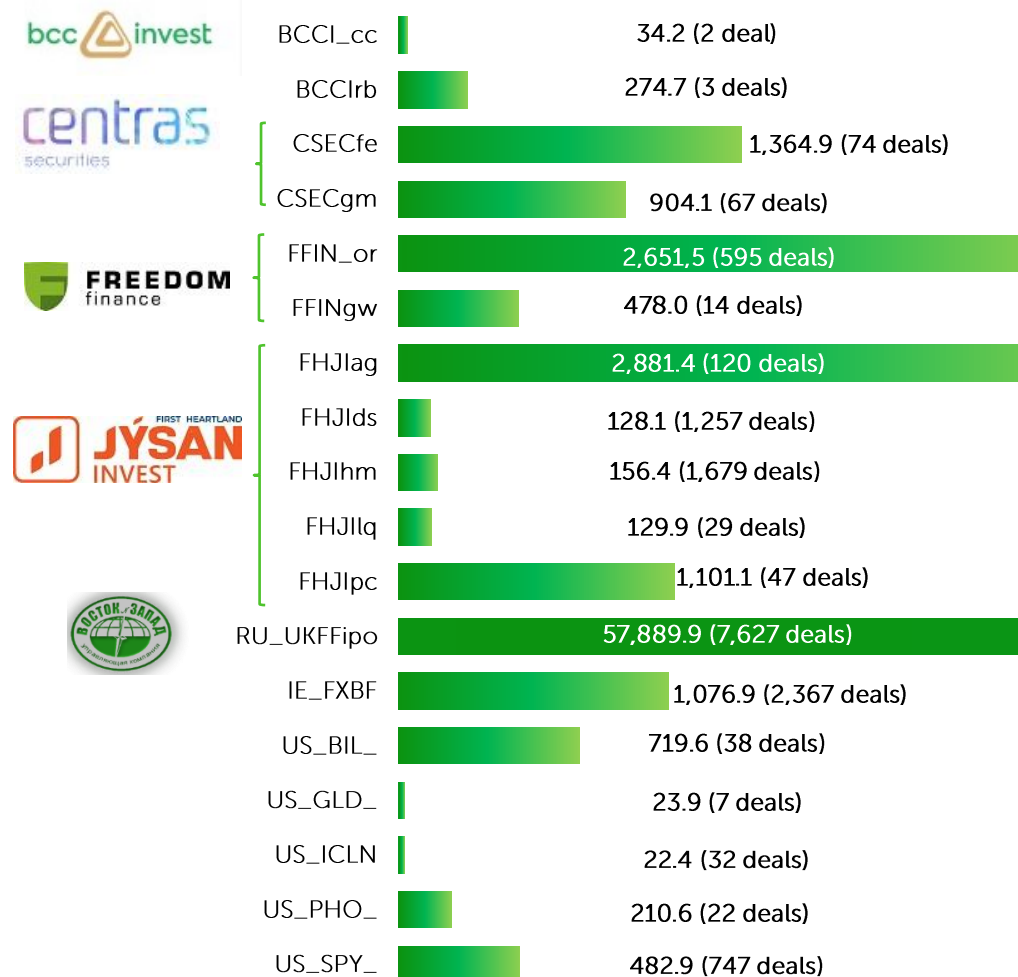


Shares of main types of investors for 8M 2021\*



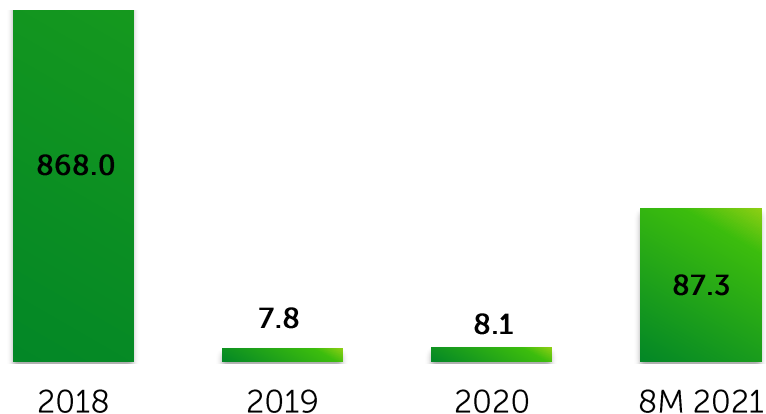

Trading volume for 8M 2021 by instruments, th. USD

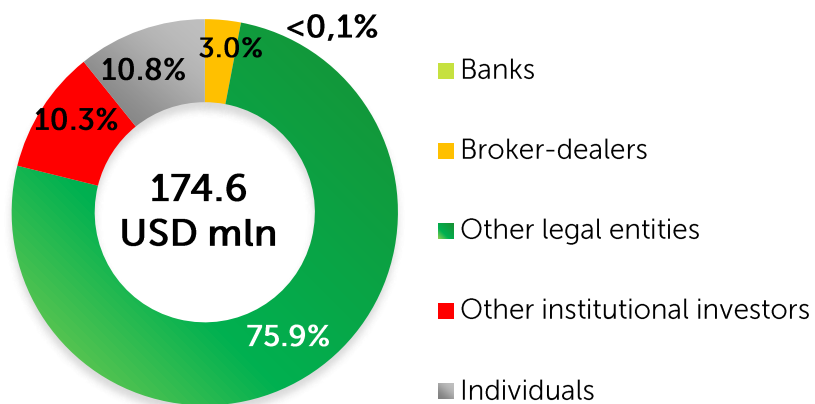

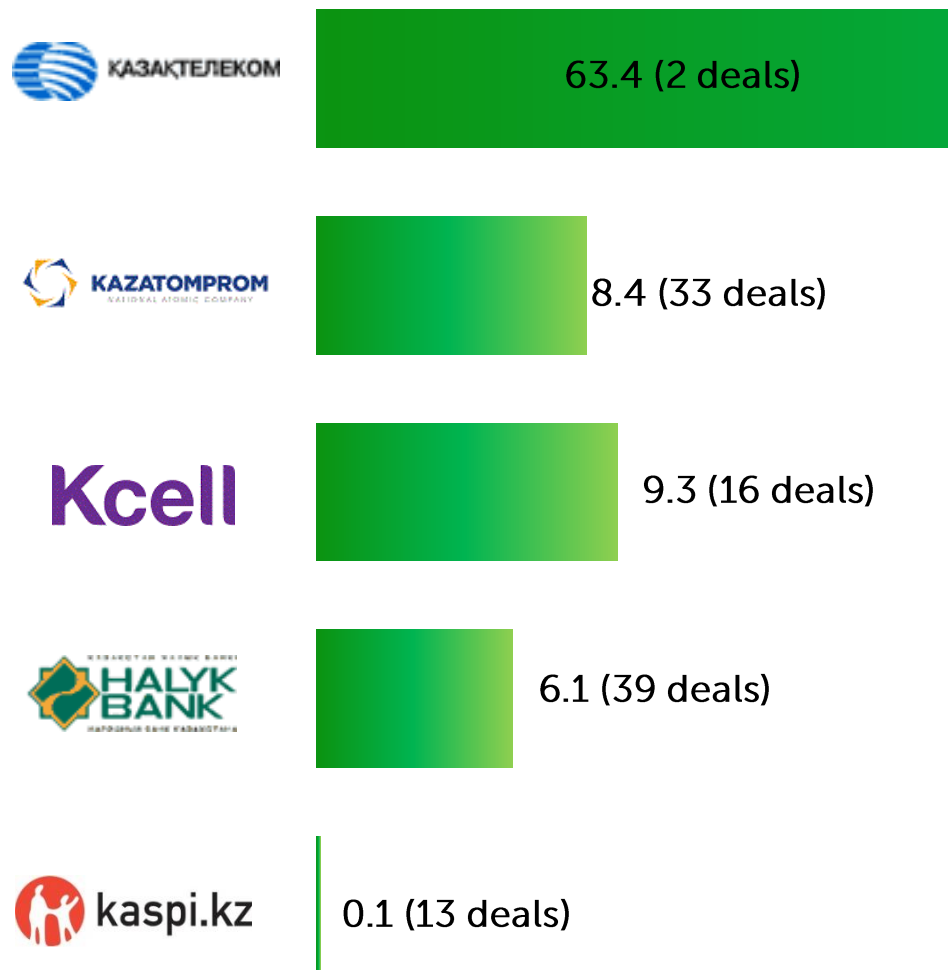

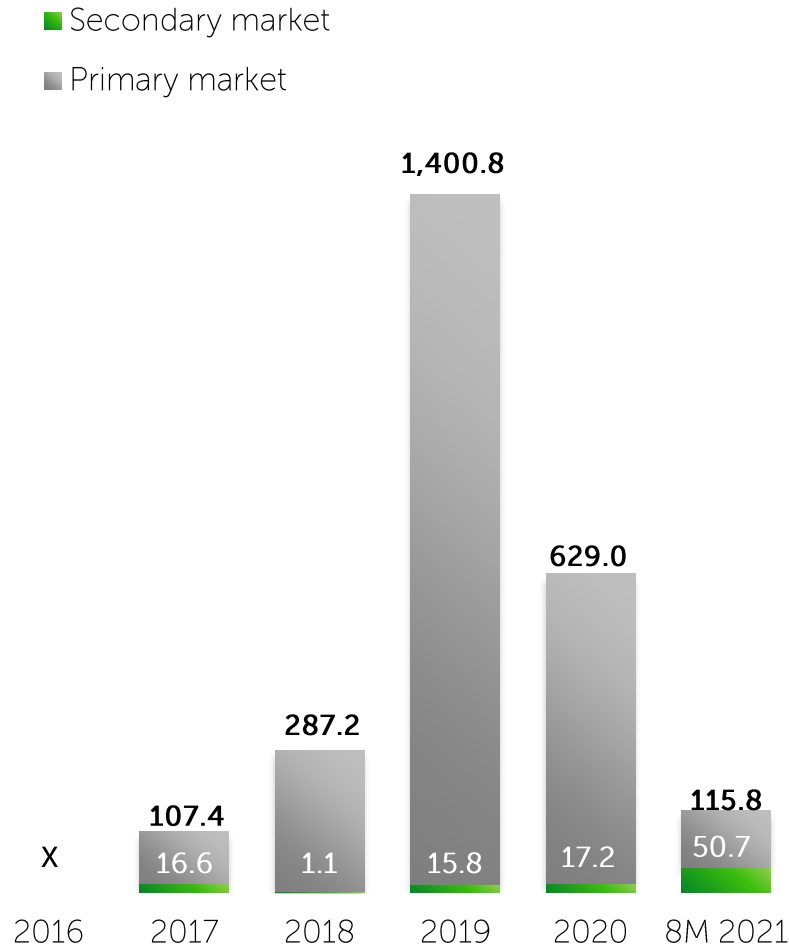

by instruments, USD mln



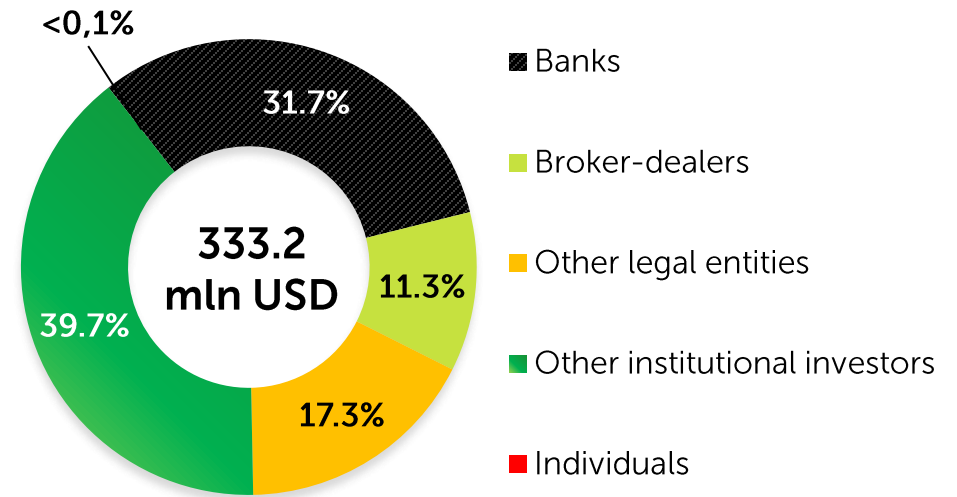
## Trading volume, USD mln

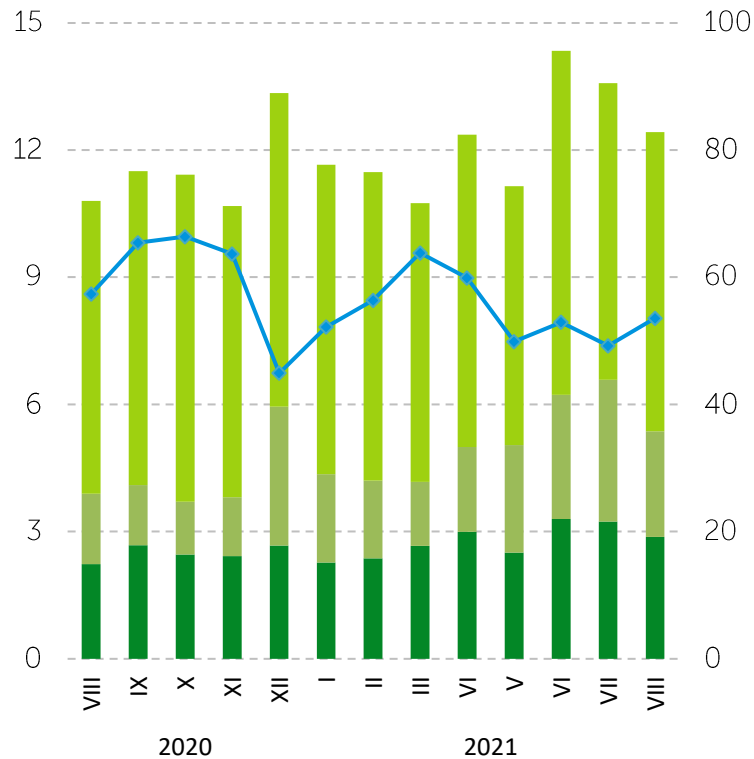

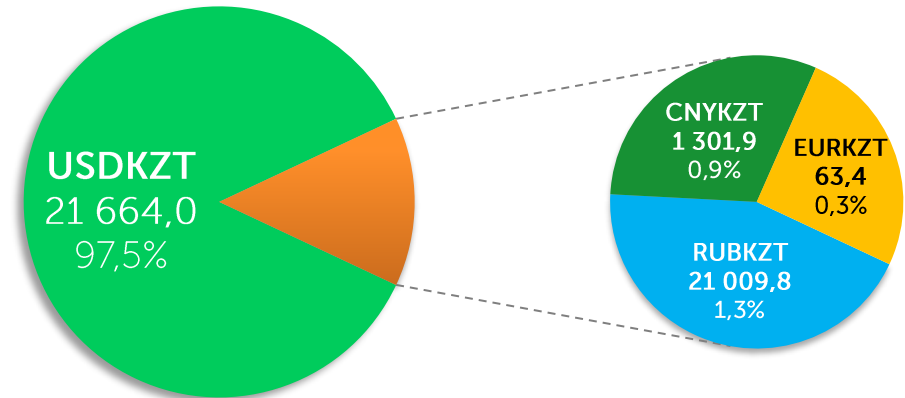

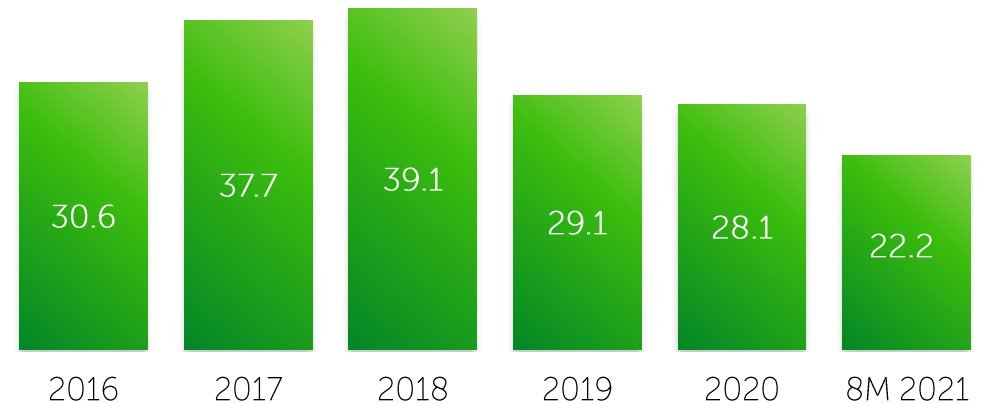


## Exchange market structure in 8M 2021, by trading volume. Volume in mln units of currency

## Trading volume on spot market, USD bn



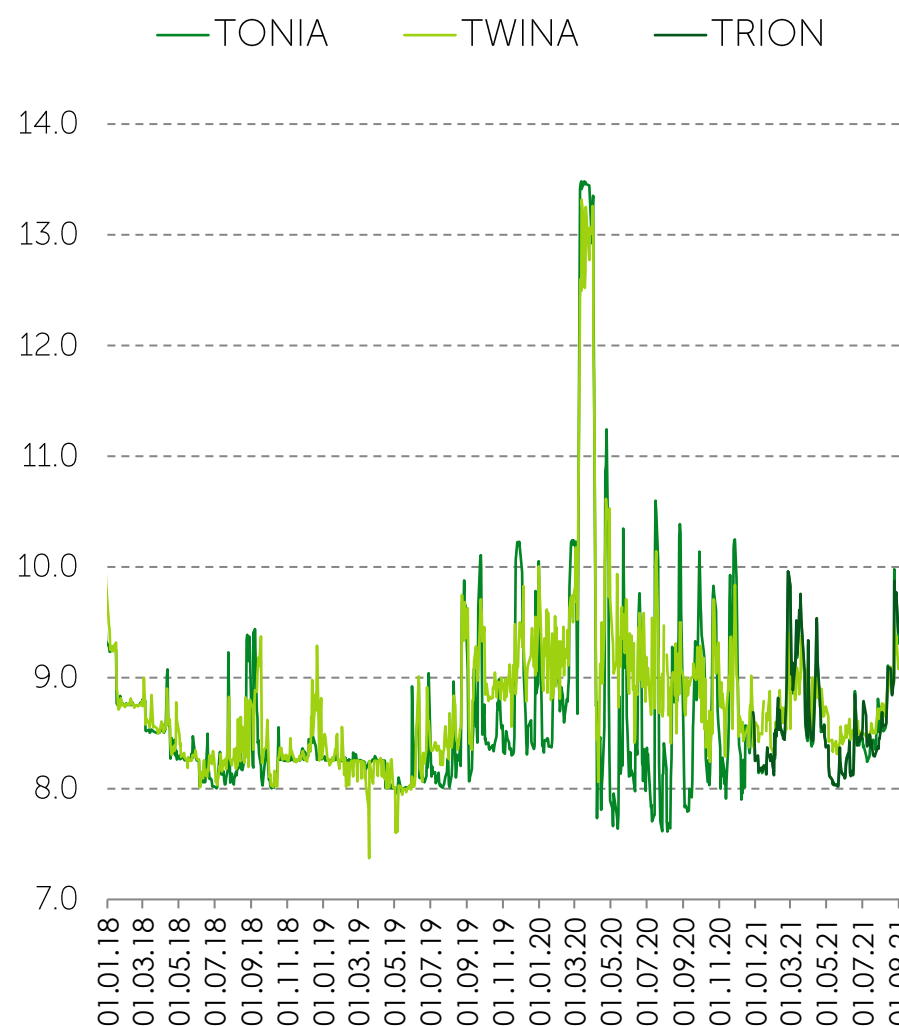

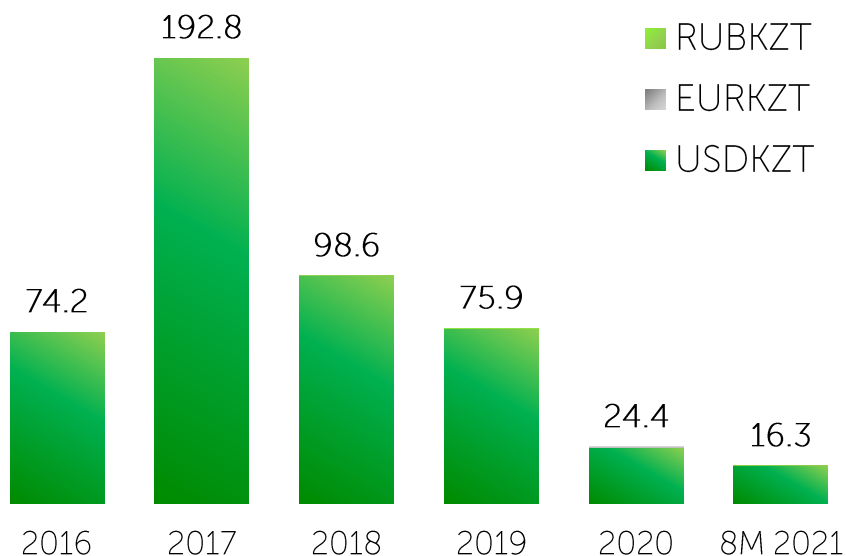

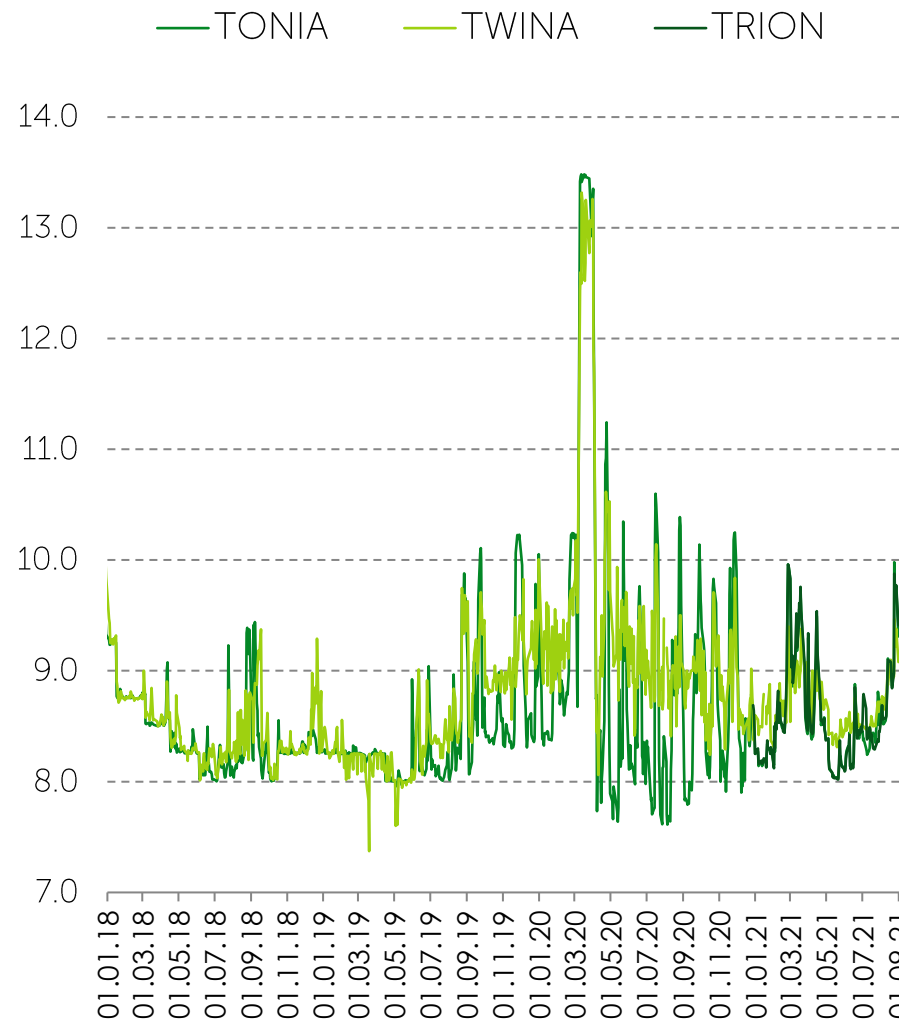
