#### **Changes in the Senior Management of BTA Bank**

Almaty, August 15, 2011. Today BTA Bank (the "Bank") informed of replacements in the senior management. Pursuant to resolutions made on July 29, 2011 at the Bank's Board of Directors meeting, Mr. Marat Zairov was appointed as a Chairman of the Management Board starting from August 15, 2011. Mr. Anvar Saidenov who headed the Management Board and was a member o the Board of Directors until now has been appointed to the position of the Chairman of the Board of Directors. Power of Mr. Arman Dumaev as Chairman of the Board of Director have been terminated by his own decision.
