Eurasian Bank Ratings Withdrawn At Issuer's Request

October 15, 2019

Rating Action

On Oct. 15, 2019, S&P Global Ratings withdrew its 'B-/B' issuer credit ratings on Kazakhstan-based JSC Eurasian Bank. The outlook was stable at the time of withdrawal.

We have also withdrawn our 'kzBB' Kazakhstan national scale ratings on the bank.

In addition, the issue ratings on all bank's debt were subsequently withdrawn.

Rationale

The ratings on Eurasian Bank reflected high economic and industry risks in Kazakhstan. We also took into account the bank's relatively weak asset quality, balanced by the expected progress in the workout of its legacy problem loans.
