Joint Stock Company Kazakhtelecom (registered address: 12 Sauran Street, Yesil District, Astana 010000, Republic of Kazakhstan; bank details: IBAN KZ446017131000000356, BIC HSBKKZKX, Halyk Bank of Kazakhstan JSC) hereby announces the payment of dividends for the financial year ended 2025. The announcement is based on the letters confirming the dividend payment (incoming Nos. 4830 and 4831 dated 15 June 2026) received from the paying agent, The Central Securities Depository JSC.

The decision to pay dividends on ordinary shares based on the results of 2025 was approved by the Annual General Meeting of Shareholders of JSC Kazakhtelecom on 30 April 2026. The list of shareholders entitled to receive dividends was determined as of 00:00 on 3 May 2026. The dividend amount per ordinary share was KZT 321.06, with the total dividend amount payable reaching KZT 3.44 billion. During the period from 28 May to 9 June 2026, dividends in the total amount of KZT 3.43 billion were paid to shareholders.

As part of the dividend payment on preferred shares, the Company paid an additional dividend of KZT 21.06 per preferred share. The guaranteed dividend on preferred shares in the amount of KZT 300.00 per share for the 2025 financial year had been paid earlier, in December 2025. The total amount of dividends payable on preferred shares is KZT 6.29 million, of which KZT 4.8 million was paid during the period from 25 May to 9 June 2026.
