

**Press release***Astana, January 25, 2016***“KazTransOil” JSC informs about 12 months of 2015 operational results**

The consolidated volume of oil transportation and oil and petroleum products transshipment of “KazTransOil” group amounted 61,001 thousand tons (1,806 thousand tons higher than the plan, but 3,003 thousand tons less than in 2014).

The consolidated oil turnover made 45,446 million tons per kilometer (1,709 million tons per kilometer higher than the plan and 1,241 million tons per kilometer higher than in 2014).

The volume of oil transportation by “KazTransOil” JSC pipelines amounted 47,541 thousand tons (1,310 thousand tons higher than the plan, but 2,492 thousand tons less than in 2014).

Oil turnover by “KazTransOil” JSC pipelines amounted 36,866 million tons per kilometer (1,474 million tons per kilometer higher than the plan and 1,033 million tons per kilometer higher than in 2014).

The volume of oil transportation by “KazTransOil” JSC pipelines to the domestic refineries decreased to 14,395 thousand tons (297 thousand tons less than the plan and 668 thousand tons less than in 2014).

Oil transportation to Atyrau Refinery amounted 4,767 thousand tons (56 thousand tons less than the plan and 22 thousand tons less than in 2014).

Oil transportation to Shymkent Refinery made 4,449 thousand tons (14 thousand tons less than the plan and 341 thousand tons less than in 2014).

Oil transportation to Pavlodar Refinery made 4,805 thousand tons (26 thousand tons less than the plan and 56 thousand tons less than in 2014).

The supply of West Kazakhstan crude oil to Pavlodar Refinery using the transit route via the territory of the Russian Federation (OPS named after T. Kasymov - Samara - TON-2 - Omsk - Pavlodar Refinery) started in December 2015. Thus, Kazakhstani shippers of crude oil have got an additional route for transportation of oil to Pavlodar Refinery. 50 thousand tons of oil was transported via this route.

Oil transportation to Bitumen Plant made 373 thousand tons (202 thousand tons less than the plan and 249 thousand tons less than in 2014).

The volume of oil transportation by “Atyrau-Samara” section of “Uzen-Atyrau-Samara” pipeline amounted 15,702 thousand tons (1,198 thousand tons higher than the plan and 1,061 thousand tons higher than in 2014).

The volume of oil transshipment to “Atasu-Alashankou” pipeline made 11,794 thousand tons (371 thousand tons higher than the plan, but 30 thousand tons less than in 2014).

The volume of oil transshipment to the tankers at the Port of Aktau using the facilities of “KazTransOil” JSC amounted 2,881 thousand tons (191 thousand tons higher than the plan, but 2,314 thousand tons less than in 2014).

The volume of oil transshipment to the CPC pipeline amounted 2,779 thousand tons (202 thousand tons less than the plan and 169 thousand tons less than in 2014).

The volume of Russian oil transportation by Kazakhstani section of TON-2 pipeline made 6,969 thousand tons (62 thousand tons higher than the plan and 186 thousand tons higher than in 2014).

The volume of fresh water supply to the customers of Atyrau and Mangistau regions of Kazakhstan via “Astrakhan-Mangyshlak” water pipeline made 24,998 thousand cubic meters (1,809 thousand cubic meters higher than the plan and 183 thousand cubic meters higher than in 2014).

The volume of oil transportation by “Kazakhstan-China Pipeline Ltd” pipelines amounted 15,870 thousand tons (269 thousand tons higher than the plan, but 277 thousand tons less than in 2014). Oil turnover made 15,664 million tons per kilometer (390 million tons per kilometer higher than the plan and 99 million tons per kilometer higher than in 2014).

The volume of oil transportation by “SWPC MunaiTas” JSC pipeline made 3,744 thousand tons (187 thousand tons higher than the plan and 718 thousand tons higher than in 2014). Oil turnover made 1,467 million tons per kilometer (79 million tons per kilometer higher than the plan and 308 million tons per kilometer higher than in 2014).

The volume of oil and petroleum products transshipment by Batumi Terminals Limited made 3,616 thousand tons (266 thousand tons higher than the plan, but 739 thousand tons less than in 2014).
