**Kazakhstan Stock Exchange JSC**

**PRESS-RELEASE**

On March 19, 2026, specialized trading in three-year bonds of KMF Bank JSC with a total volume of KZT 5 billion and a fixed yield of 21% per annum is scheduled to take place on the trading floor of the Kazakhstan Stock Exchange (KASE).

The placement is organized by Teniz Capital Investment Banking. Order submission will be available through the Tabys Pro investment application.

The nominal value of each bond is KZT 1,000, the coupon is paid quarterly, and the circulation period is 3 years (March 19, 2026 – March 19, 2029). The bank's credit rating is B+ / Stable (Fitch).

The instrument may be of interest to investors due to its high fixed yield in tenge, the opportunity to lock in the rate for a long period, and the bank's strong market position. KMF Bank JSC was established based on the country's largest microfinance organization and obtained a banking license in 2025. The company began its operations in 1997 and has held leading positions in the micro and small business financing segment for many years. As of the end of 2025, the bank's assets amounted to KZT 404 billion, the loan portfolio – KZT 317 billion, equity – KZT 70 billion, and net profit – KZT 6 billion. Amid expectations of a possible reduction in the NBRK base rate, the bonds allow investors to lock in a 21% annual yield for the entire circulation period, making the instrument attractive for investors focused on a stable cash flow.
