### Teniz Capital Investment Banking JSC becomes a Shareholder of Teniz Capital Brokerage Ltd

Teniz Capital Brokerage Ltd (a “sister” company of Teniz Capital Investment Banking JSC) increased its charter capital, as a result of which Teniz Capital Investment Banking JSC acquired a minority stake amounting to 9% of the total capital.

About Teniz Capital Brokerage Ltd:

- The company is registered in accordance with the applicable provisions and regulations of the Astana International Financial Centre (AIFC).
- On August 2, 2024, it received a license from the AIFC Financial Services Regulatory Committee to carry out dealing and brokerage activities, investment management, and investment advisory services.
- Under the Teniz Capital brand, the company will focus on serving individuals by providing access to brokerage services on international trading platforms.
- In March 2025, the company announced the acquisition of a 49% stake in Tabys Ltd — a company that owns the Tabys mobile application, launched by the Astana International Exchange (AIX) in 2020. The application is designed for participation in initial offerings and the purchase of various financial instruments on the AIX platform. As of today, the system has more than 60,000 registered users.
- The company’s charter capital amounts to 2 million US dollars.
