These Formats of clearing reports in the stock market (hereinafter – the Formats) have been developed in accordance with internal documents of Kazakhstan Stock Exchange JSC (hereinafter – the Exchange), which regulate the execution of clearing activities, and describe the forms and formats of reports provided to clearing participants.

- 1. These Formats use concepts and terms defined by the legislation of the Republic of Kazakhstan and other internal documents of the Exchange.
- 2. Clearing reports of the stock market are generated in the clearing system in the manner prescribed by the Exchange's internal document "Regulations for holding clearing sessions for transactions with the central counterparty" and are sent to clearing participants through the electronic document exchange system eTransfer.kz<sup>1</sup> (*this item was changed by a decision of the Exchange's Management Board dated July 28, 2020*).
- 3. Clearing reports of the stock market are electronic documents generated in XML (Appendices 1, 2, 3, 4, 5, 7) and PDF (Appendix 6) formats (*this item was changed by a decision of the Exchange's Management Board dated July 28, 2020*).
- 4. Each stock market clearing report in XML format contains a header in the form of text lines and a content part, which is data lines.
- 5. Each stock market clearing report in XML format can be converted to:

any format convenient for the recipient (including the TXT format with separators) by processing with the back office's own software and/or standard software (MS Excel);

to a printed form by opening the file in Microsoft Internet Explorer.
