





Cooperation Within the SCO

Investments

The total amount of China's investment in the economy of Kazakhstan exceeded **USD42.8 bn**, and lending - in total more than **USD50 bn***.

Chinese companies produce **25%** of the Kazakhstani oil

About **985** enterprises with participation of Chinese capital are represented in Kazakhstan



Through the China-Kazakhstan oil pipeline, **100 millions** tons of oil have already been delivered to China

Trade Cooperation

In 2016 the volume of bilateral trade between Kazakhstan and China reached almost **USD8 bn**.

In 2017, in January-April, trade turnover increased by **45.6%**.

Through the China-Kazakhstan gas pipeline, **183 billions** cubic meters of gas have been delivered to China

Transport and Logistics

The initiative of Chairman of China "One Belt, One Road" perfectly continues the Kazakhstani program "Nurly Zhol"

Kazakhstan becomes transit country connecting Pacific Ocean and Europe

Container transportation on the route China-Kazakhstan-Europe today **doubles** and demonstrates a **steady** positive dynamics

Main roads from China through Kazakhstan:
Northern Road to Europe
Central Road to Caspian Ocean
Southern Road to Persian gulf

The volume of rail transportation reached **8.2 millions tons**

1,5 thousand kilometers of railways were built over 4 years

3 thousand kilometers of roads were built over 4 years

Current Projects

The parties have identified **51 projects** of cooperation



Worth **USD27 bn**

3 projects have been implemented

6 projects were launched in 2016 , and another 7 projects will be launched this year

Projects in **petrochemicals, infrastructure construction and mining sector**

The projects are designed to significantly promote the **industrialization** of Kazakhstan and create new jobs in the country














Opening of trades in CNY on KASE on September 25, 2014

More than 30 transactions with the total volume of KZT 131 mln (CNY4,5 mln)

The popularity of this tool on the Exchange has grown significantly.

The volume of CNY trades reached KZT1,8 bn (CNY51,2 mln).

The volume of CNY trades in 2016 amounted to CNY 96,7 mln (which is 89% more than in 2015).


Prepayment and pre-delivery of CNY for buyers have been cancelled.

The trades in new financial instruments on the foreign currency market CNYKZT_TOM with T + 1 settlements opened



CNY/KZT: Settlement Features



In calculations based on the trade results, KASE, being a party of settlements in CNY, uses its correspondent accounts in CNY with Bank of China in Kazakhstan and with ICBC Almaty



KASE, being a party of settlements in KZT, uses its correspondent account with KZT in the National Bank of the Republic of Kazakhstan



The trading on the FX market involves trading participants, whose correspondent CNY-accounts are maintained in the same correspondent banks, where KASE has its own correspondent accounts

Trading and Settlement Procedure

CNY/KZT



10.15 – 11.00 – trading session CNY_KZT_TOD

11.00 – 11.30 – clearing session on Yuan trading



11.30 – 15.30 – trading session CNY_KZT_TOM

11.30 – 12.00 – transfer of CNY by sellers in favor of the Exchange and KZT by buyers in favor of the Exchange



12.00 – 14.00 – transfer of CNY by the Exchange in favor of buyers

16.30 – 17.30 – transfer of KZT by the Exchange in favor of sellers of CNY in the total netting of net claims for all foreign currencies

Introduction of a New Product



KASE introduces a **new financial instrument:**

CNYKZT_SPT with T + 2 settlements



Lot size - 50 000 CNY.

The open price is the price of the first transaction made on the trade session.

For CNY price deviation is 3% from the price of the latest transaction.

Reserve method is a fixing method.
